Regular Board Meeting

The Board of Education met at 7:00 p.m. on July 20, 2017, for their regular meeting at Central High School located in Camp Point.

Following the prayer and pledge, President Moore called the meeting to order and guests were introduced: Cathy Forbes, Deb Reeves, Cory Powell, and Josh Carlson. Beth Forbes, School Based Health Center Coordinator from United Way, presented a brief summary of the Wellness Express. The Wellness Express, funded by a \$300,000 grant, is the first state mobile unit to offer dental, medical & behavioral services to schools. The Regional Office of Education, Blessing Health System, Adams County Health Department, United Way, Chaddock and SIU Center for Family Medicine have all helped to provide this mobile unit. The mobile unit will be serving Adams & Brown Counties and will be staffed by area physicians. They will go to each school 4 to 5 weeks out of the school year to hopefully increase access to improved health care for those who might not have regular health services. Cory Powell, Director of Education at Chaddock along with Josh Carlson talked about Chaddock's sevices for behavioral health with the Wellness Express. The Wellness Express will be a great asset to our schools.

President Moore asked if there were any questions and/or comments from the public. Hearing none, the meeting continued.

Building

- The band shelter siding has been replaced.

- The gate valve on the lagoon is rusted and not working properly. Schuster Plumbing will be replacing this with a different valve that will not rust.
- The football field scoreboard has been installed.
- New posts are being set for installation of baseball field scoreboards.
- The gym floors will be refinished July 28th.

Finance

- Mr. Cook reported that we received our second payment out of four still owed from the State of Illinois, which leaves the state still owing the district \$258,000 from last school year.
- There was discussion on the state of Illinois school funding for next year and increase of withholding taxes to 4.95%.
- The Committee will meet in August to discuss the proposed 2017-2018 budget.
- The board approved a three year contract agreement with the Camp Point Education Association.
- The board approved a three year contract agreement with the Educational Support Staff with a two percent yearly raise. The support staff will also have the option of spreading their salary over a twelve month period instead of nine.
