1255	2-5-90	Annexing 1.26 acres of land, located on the west side of State Road 9, north of Ferguson, known as Lot No. 1 in Mini-Plat No. 146, a subdivision in the southwest quarter of Section 30, Township 21 North, Range 8 East.
1259	5-7-90	Annexing certain property owned by The Alexandria First Baptist Church, containing approximately 6.00 acres of land, and located in the northwest quarter of Section 30, Township 21 North, Range 8 East.
1274	- - 91	Annexing certain property owned by Equity One Inc. and Roselynn L. Brown, containing approximately 5.298 acres of land, and located in the southwest quarter of Section 30, Township 21 North, Range 8 East.

1265	8-20-90	Vacating a platted alley which separates Lots 1 through 6 in the Norwood Park Addition to the city from Lots 7 through 12 in the Norwood Park Addition. This alley runs from Grant Street on the south to State Road 28 on the north.
1362	11-4-96	Closing the east end of an alley running between Polk Street and Tyler Street, which portion of said alley intersects with Harrison Street.
1470	8-2-04	Vacating two alleys, one beginning at the southeast corner of Lot 381 and the other at the northeast corner of Lot 376, in the Alexandria Land and Gas Company, first addition, and vesting title thereto in the Roman Catholic Diocese of Lafayette.
1471	8-2-04	Vacating an alley beginning at the southeast corner of Lot 51 in Williams and Walkers Riverview Addition and vesting thereto in H. And R. Justice.
1480	1-18-05	Vacating two streets, one beginning at the southwest corner and the other at the northwest corner of Lot 80 in the continuation of Alexandria Land and Gas Company third addition, and vesting title thereto in the abutting land owners pursuant to state law.
