## **GENERAL PROVISIONS**

### **§ 70.01 APPLICATION.**

The provisions of this title relating to the operation of vehicles refer exclusively to the operation of vehicles upon streets and municipally-operated parking lots except where a different place is specifically referred to in a given section. ('76 Code, § 7-83) (Ord. 1144, passed 2-7-83)

**§ 70.02 SHORT TITLE.**

This Title VII shall be known and may be cited as the City Traffic Code.  
( '76 Code, § 7-84) (Ord. 1144, passed 2-7-83)

**§ 70.03 TITLE NOT RETROACTIVE.**

This title shall not have a retroactive effect. It shall not apply to any traffic accident, cause of action arising out of a traffic accident or judgment arising therefrom, or violation of the City Traffic Code occurring prior to the effective date of this title.

**§ 70.04 DEFINITIONS.**

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

***ABANDONED VEHICLE.***

- (1) A vehicle located on public property illegally;
- (2) A vehicle left on public property continuously without being moved for three days;
- (3) A vehicle located on public property in such a manner as to constitute a hazard or obstruction to the movement of pedestrian or vehicle traffic on a public right-of-way;
- (4) A vehicle which has remained on private property without the consent of the owner, or person in control, of that property, for more than 48 hours;
- (5) A vehicle from which the engine, transmission, or differential has been removed or that is otherwise partially dismantled or inoperable and left on public property;
- (6) A vehicle that has been removed by a towing service or a public agency upon request of an officer enforcing a statute or ordinance other than this chapter, if the impounded vehicle is not claimed or redeemed by the owner or his agent within 20 days after the vehicle's removal; or
- (7) A vehicle that is at least three model years old, is mechanically inoperable, and is left on private property continuously in a location visible from public property, for more than 10 days. (IC 9-13-2-1)

***ALLEY.*** A public way in an urban district that meets the following qualifications:

- (1) Is open to the public for vehicular traffic;
- (2) Is publicly maintained;

- (3) Is one lane wide;
- (4) Is designated as an alley by the local authorities on an official map of the urban district.  
(IC 9-13-2-2.5)

***AUTHORIZED EMERGENCY VEHICLE.***

- (1) Consists of the following:
  - (a) Fire department vehicles;
  - (b) Police department vehicles;
  - (c) Ambulances;
  - (d) Emergency vehicles operated by or for hospitals, or health and hospital corporations under IC 16-22-8.
- (2) Vehicles designated as emergency vehicles by the Indiana department of transportation.
- (3) Motor vehicles that, subject to IC 9-21-20-2, are approved by the Indiana emergency medical services commission that are:
  - (a) Ambulances that are owned by persons, firms, or limited liability companies, or corporations other than hospitals; or
  - (b) Not ambulances and that provide emergency medical services, including extrication and rescue services (as defined in IC 16-18-2-110).
- (4) Vehicles of the department of correction that, subject to IC 9-21-20-3, are:
  - (a) Designated by the department of correction as emergency vehicles; and
  - (b) Responding to an emergency.

***AUTOMOBILE WRECKER.*** An automobile wrecking and parts business.

***BICYCLE.*** Any foot-propelled vehicle, irrespective of the number of wheels in contact with the ground.

***BUREAU.*** The State Bureau of Motor Vehicles.

***BUSINESS DISTRICT.*** The territory contiguous to and including a highway when 50% or more of the frontage thereon for a distance of 500 feet or more is occupied by buildings in use for business.

***COMMISSIONER.*** The Commissioner of the Bureau.

**CROSSWALK**

(1) That part of a roadway at an intersection included within the connections of the lateral lines of the sidewalks on opposite sides of the highway measured from the curbs, or in the absence of curbs from the edges of the traversable roadway;

(2) Any portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrian crossing by lines or other markings on the surface.

**DISPOSAL AGENT.** Any firm or individual engaged in business as a scrap metal processor or automobile scrap yard.

**DRIVER.** Every person who drives or is in actual physical control of a vehicle.

**HOLIDAY.** The following days of the year are holidays:

- (1) The first day of January, commonly known as New Year's Day;
- (2) The last Monday of May, commonly known as Memorial Day;
- (3) The fourth day of July, commonly known as Independence Day;
- (4) The first Monday of September, commonly known as Labor Day;
- (5) The fourth Thursday of November, commonly known as Thanksgiving Day; and
- (6) December 25, commonly known as Christmas Day.

**INTERSECTION.**

(1) The area embraced within the prolongation or connection of the lateral curb lines, or if none, then the lateral boundary lines of the roadways of two highways which join one another at, or approximately at, right angles, or the area within which vehicles traveling upon different highways joining at any other angle may come in conflict; or

(2) Where a highway includes two roadways 30 feet or more apart, then every crossing of each roadway of such divided highway by an intersecting highway shall be regarded as a separate intersection. If such intersecting highway also includes two roadways 30 feet or more apart then every crossing of two roadways of such highway shall be regarded as a separate intersection.

**LOADING ZONE.** A space reserved for the exclusive use of vehicles during the loading or unloading of passengers or property.

**OFFICIAL TRAFFIC CONTROL DEVICES.** All signs, signals, markings, and devices, including railroad advance warning signs, not inconsistent with this chapter placed or erected, by authority of a public body or official having jurisdiction, for the purpose of regulating, warning, or guiding traffic.

**OWNER.**

(1) "Owner" means, except as otherwise provided in this section, when used in reference to a motor vehicle:

(a) A person who holds the legal title of a motor vehicle;

(b) A person renting or leasing a motor vehicle and having exclusive use of the motor vehicle for more than 30 days; or

(c) If a motor vehicle is the subject of an agreement for the conditional sale or lease vested in the conditional vendee or lessee, or in the event the mortgagor, with the right of purchase upon the performance of the conditions stated in the agreement and with an immediate right of possession of a vehicle is entitled to possession, the conditional vendee or lessee or mortgagor.

(2) "Owner," for purposes of IC 9-21 and IC 9-25, means, when used in reference to a motor vehicle, a person who holds the legal title of a motor vehicle, or if a:

(a) Motor vehicle is the subject of an agreement for the conditional sale or lease of the motor vehicle with the right of purchase upon performance of the conditions stated in the agreement and with an immediate right of possession vested in the conditional vendee or lessee; or

(b) Mortgagor of a motor vehicle is entitled to possession; the conditional vendee or lessee or mortgagor is considered to be the owner for the purpose of IC 9-21 and IC 9-25.

(3) "Owner," for purposes of IC 9-22-1, means the last known record titleholder of a vehicle according to the records of the bureau under IC 9-17.

(4) "Owner," for purposes of IC 9-31, means a person, other than a lienholder, having the property in or title to a motorboat. The term includes a person entitled to the use or possession of a motorboat subject to an interest in another person reserved or created by agreement and securing payment or performance of an obligation. The term excludes a lessee under a lease not intended as security. (IC 9-13-2-121)

**PARK or PARKING.** The standing of a vehicle, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading merchandise of passengers.

**PARKING PLACE or PARKING SPACE.** A designated portion of the surface of a street of sufficient length and depth to accommodate a vehicle of reasonable dimensions to be parked.

**PARTS.** All vehicle components that as assembled do not constitute a complete vehicle.

**PEDESTRIAN.** Any person afoot.

**PERSON.** Every natural person, firm, co-partnership, association, and corporation.

**POLICE OFFICER.** Every officer authorized to enforce this chapter.

**PRIVATE PROPERTY.** All property other than public property.

**PUBLIC AGENCY.** For the purposes of fulfilling the local responsibility for removal, storage and disposal of abandoned vehicles, the Police Department.

**PUBLIC PROPERTY.** Any public right-of-way, street, highway, alley, park, or other state, county, or municipal property.

**RESIDENCE DISTRICT.** The territory contiguous to and including a highway not comprising a business district, when the property on such highway for a distance of 500 feet or more is in the main improved with residences or residences and buildings in use for business.

**RIGHT OF WAY.** The privilege of the immediate use of the highway.

**ROADWAY.** That portion of a highway improved, designed, or ordinarily used for vehicular travel.

**SCRAP METAL PROCESSOR.** An establishment having facilities for processing iron, steel, or nonferrous scrap and whose principal product is scrap iron and scrap steel or nonferrous scrap for sale for remelting purposes. A scrap metal processor is not a disposal facility or a used parts dealer.

**SIDEWALK.** That portion of a street between the curb lines, or the lateral lines of a roadway, and the adjacent property lines intended for the use of pedestrians.

**STAND or STANDING.** The halting of a vehicle, whether occupied or not, otherwise than temporarily for the purpose of, and while actually engaged in, receiving or discharging passengers.

**STATE LAW.** State laws regulating and relating to motor vehicles and their operation.

**STOP.** When required, means complete cessation from movement.

**STOP or STOPPING.** When prohibited, means any halting, even momentarily, of a vehicle, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control device or signal.

**STREET or HIGHWAY.** The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.

**TOWING SERVICE.** A business that engaged in moving or removing disabled vehicles and, once removed, to store or impound vehicles.

**TRAFFIC.** Pedestrians, ridden or herded animals, street cars, vehicles, and other conveyances either singly or together while using any highway for purposes of travel.

## **TRUCK**

(1) "Truck" means a motor vehicle designed, used, or maintained primarily for the transportation of property.

(2) "Truck," for purposes of IC 9-21-8-3, includes the following:

(a) A motor vehicle designed and used primarily for drawing another vehicle and constructed to carry a load other than a part of the weight of the vehicle and load so drawn;



(b) A motor vehicle designed and used primarily as a farm implement for drawing plows, mowing machines, and other implements of agriculture.  
(IC 9-13-2-188)

**VEHICLE.** Shall mean, except as otherwise provided in this section, a device in, upon, or by which a person or property is, or may be, transported or drawn upon a highway.

(1) "Vehicle," for purposes of IC 9-14 through IC 9-18, does not include the following:

(a) A device moved by human power.

(b) A vehicle that runs only on rails or tracks.

(c) A vehicle propelled by electric power obtained from overhead trolley wires but not operated upon rails or tracks.

(d) A firetruck and apparatus owned by a person or municipal division of the state and used for fire protection.

(e) A municipally owned ambulance.

(f) A police patrol wagon.

(g) A vehicle not designed for or employed in general highway transportation of persons or property and occasionally operated or moved over the highway, including the following:

1. Road construction or maintenance machinery;

2. A movable device designed, used, or maintained to alert motorists of hazardous conditions on highways;

3. Construction dust control machinery;

4. Well boring apparatus;

5. Ditchdigging apparatus;

6. An implement of agriculture designed to be operated primarily in a farm field or on farm premises;

7. An invalid chair;

8. A yard tractor.

(2) For purposes of IC 9-20 and IC 9-21, the term does not include devices moved by human power or used exclusively upon stationary rails or tracks.

(3) For purposes of IC 9-22, the term refers to an automobile, a motorcycle, a truck, a trailer, a semitrailer, a tractor, a bus, a school bus, a recreational vehicle, or a motorized bicycle.

(4) For purposes of IC 9-30-5, IC 9-30-6, IC 9-30-8, and IC 9-30-9, the term means a device for transportation by land or air. The term does not include an electric personal assistive mobility device. (IC 9-13-2-196)

**YARD TRACTOR.** A tractor that is used to move semitrailers around a terminal or a loading or spotting facility. The term also refers to a tractor that is operated on a highway with a permit issued under IC 6-6-4.1-13(e) if the tractor is ordinarily used to move semitrailers around a terminal or spotting facility. (IC 9-13-2-201)

## **ADMINISTRATION AND ENFORCEMENT**

### **§ 70.15 DUTY OF THE CHIEF OF POLICE.**

The Chief of Police and his or her deputies shall enforce all city traffic regulations, and all state laws, make arrests for traffic violations, investigate accidents, cooperate with city officials in the administration of the traffic laws and in developing ways to improve traffic conditions, and carry out those duties imposed upon the Chief of Police and deputies by this chapter.

### **§ 70.16 RECORDS OF TRAFFIC VIOLATIONS.**

(A) The Police Department shall keep a record of all violations of this chapter or the state laws of which any person has been charged together with a record of the final disposition of all such alleged offenses. The record shall show all types of violations and the total of each. The record shall accumulate during at least a five year period and from that time on the record shall be maintained complete for at least the most recent five-year period.

(B) All forms for records of violations and notices of violations shall be serially numbered. For each month and year a written record shall be kept available to the public showing the disposal of all such forms.

(C) All such records and reports shall be public records.

### **§ 70.17 POLICE DEPARTMENT TO INVESTIGATE ACCIDENTS.**

The Chief of Police and deputies shall investigate traffic accidents and arrest and assist in the prosecution of those persons charged with violations of law causing or contributing to such accidents.

### **§ 70.18 TRAFFIC ACCIDENT STUDIES.**

Whenever accidents at any particular location become numerous, the Police Department shall cooperate with city officials in conducting studies of such accidents and determining remedial measures.

**§ 70.19 TRAFFIC ACCIDENT REPORTS.**

The Police Department shall maintain a suitable system of filing traffic accident reports. Accident reports or cards referring to them shall be filed alphabetically by location. These reports shall be available for the use and information of city officials, and in accordance with IC 9-26-2-3. ('76 Code, § 7-6) (Ord. 1144, passed 2-7-83)

**§ 70.20 WRITTEN REPORTS OF ACCIDENTS.**

(A) The city requires that the driver of a vehicle involved in an accident also file with the Police Department a report of that accident or a copy of any report required by IC 9-26-1-1 to be filed with the State Police Department. This section shall not apply if the driver was present at the scene of the accident during the investigation by the Chief of Police or any other police officer. ('76 Code, § 7-16)

(B) If the driver is not the owner of the vehicle and is physically unable to file the report required by § 70.24(A), the owner of the vehicle shall file this report within five days after learning of the accident. ('76 Code, § 7-17)

(C) All written accident reports made by drivers, owners or occupants, of vehicles involved in accidents, as required in divisions (A) and (B), shall be without prejudice to the individual so reporting, and shall be for the confidential use of the Chief of Police or other governmental agencies having use of the records for accident prevention purposes, except that the Chief of Police may disclose the identity of a person involved in an accident when such identity is not otherwise known, or when that person denies his presence at that accident. No report shall be used as evidence in any trial, civil or criminal, arising out of any accident, except that the Chief of Police shall furnish upon demand of any person who has, or claims to have, made to the Chief of Police, solely to prove a compliance or a failure to comply with the requirements that a report be made to the Police Department, or as required by IC 9-26-3-4. ('76 Code, § 7-18)

**§ 70.21 POLICE DEPARTMENT TO SUBMIT ANNUAL TRAFFIC REPORT.**

The Police Department shall prepare a traffic report which shall be filed with the Common Council annually. The report shall contain information on city traffic matters including:

(A) The number of traffic accidents, the number of persons killed, the number of persons injured, and other pertinent traffic accident data;

(B) The number of traffic accidents investigated and other pertinent data on Police Department safety activities; and

(C) Any plans and recommendations of the Police Department for future traffic safety activities. ('76 Code, § 7-7) (Ord. 1144, passed 2-7-83)

**§ 70.22 EMERGENCY TRAFFIC CONTROL.**

The Chief of Police may place temporarily official traffic control devices when required by an emergency. The Chief of Police shall notify the Mayor of his actions as soon as possible thereafter. ('76 Code, § 7-8) (Ord. 1144, passed 2-7-83)

**§ 70.23 IDENTIFYING FUNERAL PROCESSIONS.**

The Chief of Police shall approve types of pennants or other identifying insignias to be displayed upon or other methods to be employed to identify the vehicles in funeral processions in accordance with IC 9-21-13-5.

**§ 70.24 TRAFFIC ENGINEER.**

The Chief of Police shall serve as City Traffic Engineer.

**§ 70.25 AUTHORITY OF CHIEF OF POLICE AND FIRE DEPARTMENT OFFICIALS.**

(A) The Chief of Police and deputies or any officers assigned by the Chief of Police shall enforce this chapter and state laws.

(B) The Chief of Police and deputies, or any officers assigned by the Chief of Police, may direct all traffic by voice, hand or signal in conformance with traffic laws, provided that, in the event of a fire or other emergency or to expedite traffic or safeguard pedestrians, the Chief of Police and deputies may direct traffic as conditions may require, notwithstanding the provisions of this chapter.

(C) Fire Department officers, when at the scene of a fire, may direct or assist the Chief of Police and deputies or officers in directing traffic in the immediate vicinity.

**§ 70.26 CERTAIN NONMOTORIZED TRAFFIC TO OBEY TRAFFIC REGULATIONS.**

Every person propelling a pushcart, riding an animal, or driving any animal-drawn vehicle upon a roadway shall be granted all of the rights and shall be subject to all of the duties applicable to the driver of a vehicle by this chapter except those provisions of this chapter which by their very nature can have no application.

**§ 70.27 PUBLIC EMPLOYEES TO OBEY TRAFFIC REGULATIONS.**

The provisions of this chapter shall apply to the drivers of all vehicles owned or operated by the United States, this state, or any political subdivision of the state, subject to such specific exceptions as are set forth in this chapter or in state law. The provisions of the chapter shall not apply to persons, motor vehicles and other equipment while actually engaged in work in a street but shall apply to these persons and vehicles when traveling to or from work.

**§ 70.28 DISPOSITION OF TRAFFIC FINES.**

All fines or forfeitures collected upon conviction of any person charged with a violation of any of the provisions of this chapter shall be deposited in the City General Operating Fund.

**VEHICLE INSPECTION****§ 70.40 INSPECTION FEE.**

There is established a fee of \$5 for each inspection by a regular member of the Police Department of any motor vehicle, semitrailer or recreational vehicle.

**§ 70.41 DEPOSIT OF FUNDS.**

The revenue from the inspection fee shall be deposited in a local law enforcement continuing education fund, as set forth in Public Law 48.

**§ 70.42 APPROPRIATIONS.**

Said funds must be appropriated by the Common Council for the money collected from the inspections only for law enforcement purposes.

**§ 70.99 PENALTY.**

(A) Unless another penalty is expressly provided by law, every person convicted of a violation of any provision of this chapter shall be punished by a fine of not more than \$100 for each violation. If any person is convicted of a third or subsequent offense committed within one year after the date of the first offense, that person shall be fined not more than \$1,000. Each date a violation continues constitutes a separate offense.

(B) (1) An Ordinance Violations Bureau as authorized under IC 34-28-5-1 through 34-28-5-14 is established and instituted for the purposes of collecting fines for certain municipal ordinance violations.

(2) There is established and instituted pursuant to the creation of the Ordinance Violations Bureau, an Ordinance Violation Fund for the purpose of purchasing, maintaining and upkeeping police radio equipment.

(3) The municipal ordinances for which said Ordinance Violation Bureau is hereby established and the corresponding fines to be imposed and collected thereunder are as follows:

(C) The maximum fine to be imposed for any single occurrence of a municipal ordinance as specified hereinabove is \$50.

(D) The Clerk-Treasurer is hereby designated as the Ordinance Violations Bureau Clerk for the purpose of collecting and depositing the fines for said ordinance violations.

### **GENERAL PROVISIONS**

#### **§ 71.01 AUTHORITY TO INSTALL TRAFFIC-CONTROL DEVICES.**

The Chief of Police shall place and maintain official traffic-control devices as required under this chapter and may place and maintain additional official traffic-control devices deemed necessary to warn or guide traffic under the provisions of this chapter or state law.  
(76 Code, § 7-19) (Ord. 1144, passed 2-7-83)

**§ 71.02 WHEN OFFICIAL TRAFFIC-CONTROL DEVICES ARE REQUIRED FOR ENFORCEMENT PURPOSES.**

No provisions of this chapter for which official traffic-control devices are required shall be enforced against an alleged violator if, at the time and place of the alleged violation, an official device is not in proper position and sufficiently legible to be seen by an ordinarily observant person.

(A) Whenever official traffic-control device are placed in positions approximately conforming to the requirements of this chapter, such devices shall be presumed to have been so placed by the official act or direction of lawful authority, unless the contrary shall be established by competent evidence.

(B) Any official traffic-control device placed pursuant to the provisions of this chapter and purporting to conform to the lawful requirements pertaining to such devices shall be presumed to comply with the requirements of this chapter, unless the contrary shall be established by competent evidence.

**§ 71.04 CROSSWALKS AND ESTABLISH SAFETY ZONES.**

The Chief of Police shall, at the direction of the Common Council, designate and maintain, by appropriate devices, marks or lines upon the surface of the roadway, crosswalks at intersections, where in its opinion, there is particular danger to pedestrians crossing the roadway, and at such other places as it may deem necessary.

**§ 71.05 TRAFFIC LANES.**

The Chief of Police shall, at the direction of the Common Council, mark traffic lanes upon the roadway of any street or highway under the jurisdiction of the city.

**§ 71.06 AUTHORITY TO PLACE DEVICES ALTERING NORMAL COURSE FOR TURNS.**

The Chief of Police may place official traffic-control devices, within or adjacent to intersections, indicating the course to be traveled by vehicles turning at those intersections. The course to be traveled as so indicated may conform to, or be other than that prescribed by law.

**§ 71.07 LIMITATIONS ON TURNING AROUND.**

The Council may designate those intersections at which drivers of vehicles shall not make a right, left, or U turn, and shall place proper signs at those intersections. The making of such turns may be



prohibited between certain hours and permitted at other hours, in which event the same shall be plainly indicated on the signs, or they may be removed when those turns are permitted.

**§ 71.09 INTERSECTIONS WHERE STOP OR YIELD IS REQUIRED.**

The Council may designate intersections where a particular hazard exists and to determine whether vehicles shall stop at one or more entrances to any such intersection, in which event it shall erect a stop sign at every such place where a stop is required, or whether vehicles shall yield the right-of-way to vehicles on a different street at such intersection, in which event it shall erect a yield sign at every place where obedience thereto is required.

Official traffic control signals shall be installed at the following locations:

(E) Church Street and Harrison Street.

(F) Harrison Street and John Street.

(G) Harrison Street and Washington Street.

**§ 71.11 RESTRICTED USE OF ALLEY.**

The east half of the alley on the west side Harrison Street between Church Street and John Street shall be closed to all vehicular traffic except authorized emergency vehicles.

**SPEED REGULATIONS****§ 71.25 STATE SPEED LAWS APPLICABLE.**

(A) The state laws regulating the speed of vehicles shall be applicable upon all streets within this city, except as this chapter, as authorized by state law, hereby declares and determines, upon the basis of engineering and traffic investigations, that certain speed regulations shall be applicable upon specified streets or in certain areas, in which event it shall be unlawful for any person to drive a vehicle at a speed in excess of any speed so determined when signs are in place giving notice thereof.

(B) Whoever violates this section shall be subject to the penalty provisions of IC 9-21-5-13.

**§ 71.40 FUNERAL PROCESSIONS TO BE IDENTIFIED.**

A funeral composed of a procession of vehicles shall be identified as such by the display upon the outside of each vehicle of a pennant or other identifying insignia or by such other method as may be determined and designated by the Chief of Police.

**§ 71.41 PERMIT REQUIRED FOR PARADE AND PROCESSION; EXCEPTION.**

(A) It shall be unlawful for any member of a procession or parade to occupy, march, or proceed along any street or public way without a permit from the Chief of Police.

(B) The Chief of Police shall issue a parade permit only if it is in the public interest to do so. If the chief should deny any person a parade permit, then the Common Council shall review said action of the Chief of Police and determine whether it was correct.

(C) The Chief of Police may impose such conditions upon a parade permit as he deems to be reasonable and necessary for the public safety; provided, however, that any person may, prior to the conduct of the parade or procession for which the permit is granted, appeal the imposition of the conditions by the Chief of Police to the Common Council. Upon an appeal, the Common Council shall determine whether the conditions so imposed were reasonable and may order the removal of such conditions or the imposition of other conditions as it deems reasonable.

(D) It shall be unlawful for any person to violate any of the conditions imposed in any parade permit granted to him.

## **GENERAL PROVISIONS**

### **§ 72.01 APPLICATION.**

(A) The provisions of this chapter shall apply except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control device.

(B) The provisions of this chapter shall not relieve any person from the duty to observe other and more restrictive provisions prohibiting or limiting the stopping, standing or parking of vehicles in specified places or times.

### **§ 72.02 ANGLE PARKING.**

The Council shall determine and designate the streets upon which angle parking shall be permitted. Angle parking shall not be permitted upon any federal-aid or state highway.

### **§ 72.03 PARKING NOT TO OBSTRUCT TRAFFIC.**

No person shall park any vehicle upon a street, other than an alley so that less than 10 feet of the width of the roadway is available for the free movement of traffic.

### **§ 72.04 PARKING RESTRICTED IN ALLEYS.**

No operator of any vehicle shall stop, stand, or park that vehicle in any alley for a period of time longer than is necessary for the loading or unloading of passengers or freight. No person shall stop, stand, or park in any alley so that less than eight feet of the width of the alley is available for the free movement of traffic. If less than eight feet of the width of the alley is available, the operator of the vehicle shall move it immediately if another vehicle approaches.

**§ 72.05 PARKING FOR CERTAIN PURPOSES PROHIBITED.**

No person shall park a vehicle upon any roadway to display it for sale, or to grease or repair the vehicle, except if repairs are required by an emergency.

**§ 72.06 OBEDIENCE TO PARKING SIGNS OR MARKINGS.**

No person shall park or stand a vehicle in any location which has been signed or marked for parking except within the markings and at the orientation indicated by the signs or markings.

**§ 72.07 TRUCK AND BUS PARKING.**

(A) *Residential District.* No person owning or operating a truck, trailer, bus, recreational vehicle, tractor, or tractor and trailer which is wider, longer, or taller than a conventional station wagon or pick-up truck shall park that vehicle on or upon any street or alley within any residential district. This section shall not prevent any vehicle from parking for a sufficient time to make deliveries or pick up merchandise if the parking does not interrupt the regular traffic flow and does not create a safety hazard.

(B) *Business District.* No person shall park any vehicle listed in subsection (A) of this section upon any street or alley longer than one hour within any business district. This subsection shall not prevent any vehicle from parking for a sufficient time to make deliveries or pick up merchandise in the regular course of business if the parking does not interrupt regular traffic flow and does not create a safety hazard.

(C) Any vehicle listed in subsection(A) above may park on or upon any street or alley in a business or residential district if the owner of the vehicle has first obtained written permission from the Police Department. The permit shall state the location where the vehicle may be parked and the duration for which the parking shall be allowed.

**§ 72.08 STANDING OR PARKING PROHIBITED OFF ROADWAY.**

No person shall stand or park a vehicle on a street other than on the roadway or paved shoulder.

**§ 72.09 STANDING OR PARKING PROHIBITED AT ALLEYS.**

No person shall stand or park a vehicle on a street so that it restricts full access to any alley.

**§ 72.10 PARKING RESTRICTED IN BUSINESS DISTRICT.**

No person shall park a vehicle for more than two consecutive hours in a business district. ('76 Code, § 7-66) (Ord. 1144, passed 2-7-83) Penalty, see § 70.99

**§ 72.11 MAYOR TO HAVE AUTHORITY TO CLOSE MUNICIPAL PARKING LOTS.**

(A) The Mayor, by executive order, shall have the authority to direct the Chief of Police of the city to close one or more of the public parking lots, owned and/or maintained by the city, for such period of time as is directed in the order of the Mayor.

(B) Once receiving such order, the Chief of Police shall proceed to close the designated parking lot or lots, listed in the order by the Mayor, for such period of time as set out in the order, by locking the parking lot entrances and posting no parking signs, setting forth the time that no parking is allowed.

(C) After the no parking signs are posted, any person parking on the parking lot or parking lots shall be guilty of a Class C infraction and shall be subject to the penalty provisions of § 70.99. (Ord. 1261, passed 7-16-90) Penalty, see § 70.99

**HANDICAPPED PARKING****§ 72.25 DEFINITIONS; HANDICAPPED SPACES.**

For the purpose of this subchapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

**MOTOR VEHICLE.** As set forth in IC 9-13-2-105.

**PHYSICALLY HANDICAPPED PERSON.** A person who has been issued a placard under IC 5-16-9, or a handicapped registration plate for a motor vehicle by the Bureau of Motor Vehicles under IC 9-18-22-1.

**§ 72.26 REQUIRED IDENTIFICATION.**

A motor vehicle parked in a space reserved for the physically handicapped shall have it displayed on the motor vehicle in a place that may be viewed by the public, at least one of the following:

(A) An unexpired handicapped parking permit issued under IC 9-14-5; or

(B) An unexpired disabled veteran's registration plate issued under IC 9-18-18; or

(C) An unexpired handicapped registration plate or decal issued under IC 9-18-22-1; or

(D) An unexpired handicapped parking permit, an unexpired disabled veteran's registration plate, or an unexpired handicapped registration plate or decal issued under the laws of another state to stand or park in a space reserved for the physically handicapped.

#### **§ 72.27 HANDICAPPED SIGNS POSTED.**

Reserved spaces for handicapped parking must be reserved by posting immediately adjacent to and visible from the space or spaces a sign bearing:

(A) The official international wheelchair symbol;

(B) A reasonable facsimile of that symbol; or

(C) A facsimile of the symbol displayed on the handicapped person's motor vehicle registration plate.

#### **§ 72.28 VIOLATIONS OF HANDICAPPED PARKING.**

(A) Any person who parks a motor vehicle which does not have displayed a handicapped person's or a disabled veteran's placard issued under IC 9-14-5, or under the laws of another state, or a handicapped or disabled veteran's registration plate, issued under IC 9-18-18, IC 9-18-22-1, or under the laws of another state, in a parking space reserved under this subsection for a handicapped person's parking vehicle, commits a Class C infraction.

(B) Any person who knowingly parks in a reserved handicapped parking space while displaying a placard to which neither he nor his passenger is entitled, commits a Class C infraction.

(C) Any person who displays for use in parking in a reserved handicapped parking space a placard or special license plate that was not issued under IC 5-16-9 and IC 9-18-18-2 et seq., or under the laws of another state, commits a Class C infraction.

### **LOADING AND UNLOADING**

#### **§ 72.40 PARKING IN LOADING ZONE.**

No person shall stop, stand, or park a vehicle for any purpose or period of time, other than for the expeditious loading or unloading of passengers or materials, in any place marked as a loading zone during the hours and days when the regulations applicable to such curb loading zone are effective, and then only for a period not to exceed three minutes for passengers or 20 minutes for materials.

**§ 72.41 COMMON COUNCIL TO DESIGNATE LOADING ZONES.**

The Council shall designate the location of loading zones by placing and maintaining appropriate signs. The signs shall state the hours and days during which the provisions of this section are applicable.

***ABANDONED VEHICLES*****§ 72.55 APPLICABILITY; DEFINITIONS.**

(A) This subchapter does not apply to the following:

(1) A vehicle in operable condition specifically adapted or constructed for operation on privately owned raceways;

(2) A vehicle stored as the property of a member of the armed forces of the United States who is on active duty assignment;

(3) A vehicle located on a vehicle sale lot or at a commercial vehicle servicing facility;

(4) A vehicle located upon property licensed or zoned as an automobile scrapyard; or

(5) A vehicle registered and licensed under IC 9-18-12 as an antique vehicle.  
(IC 9-22-1-1)

(B) For the purpose of this subchapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

***ABANDONED VEHICLE.*** Includes but is not limited to the following definitions:

(a) Any vehicle located on public premises which does not have lawfully affixed thereto or displayed thereon a valid unexpired license plate permitting its operation upon the highways of the state.

(b) Any vehicle which is parked or located on public premises continuously without being moved for a period of three days except before legal or temporary residence of the owner.

(c) Any vehicle parked or located on public premises illegally or in such a manner as to constitute a hazard or obstruction to the movement of pedestrian or other vehicle traffic on a public right-of-way, street, or highway.

(d) Any vehicle that is over six years old and mechanically inoperable and is left unattended on private premises in a location which is visible from public premises for more than 30 days.

(e) Any vehicle that has remained on private premises without the consent of the owner or person in control of such premises for more than 48 hours.



(f) Any vehicle from which there has been removed the engine or transmission or differential or which is otherwise partially dismantled or inoperable and left unattended on private premises in a location visible from public premises or left unattended on public premises.

**§ 72.56 RESPONSIBILITY OF OWNER.**

(A) Except as provided in division (C) of this section, the person who owns an abandoned vehicle or parts is:

(1) Responsible for the abandonment; and

(2) Liable for all of the costs incidental to the removal, storage, and disposal of the vehicle or parts under this chapter.

(B) The costs for storage of an abandoned vehicle may not exceed \$1,500.

(C) If an abandoned vehicle is sold by a person who removed, towed, or stored the vehicle, the person who previously owned the vehicle is not responsible for storage fees.

(D) If an abandoned vehicle is sold by a person who removed, towed, or stored the vehicle, and proceeds from the sale of the vehicle covered the storage expenses, any remaining proceeds from the sale of the vehicle shall be returned to the previous owner of the vehicle if the previous owner is known.

**§ 72.57 INABILITY TO ESTABLISH RIGHT TO POSSESSION.**

When an officer discovers a vehicle in the possession of a person other than the person who owns the vehicle and the person cannot establish the right to possession of the vehicle, the vehicle shall be taken to and stored in a suitable place.

(IC 9-22-1-5)

**§ 72.58 NOTICE TAG PREPARED BY POLICE OFFICER.**

An officer who finds or is notified of a vehicle or parts believed to be abandoned shall attach in a prominent place a notice tag containing the following information:

(A) The date, time, officer's name, public agency, and address and telephone number to contact for information;

(B) That the vehicle or parts are considered abandoned;

(C) That the vehicle or parts will be removed after 72 hours;

(D) That the person who owns the vehicle will be held responsible for all costs incidental to the removal, storage, and disposal of the vehicle; and

(E) That the person who owns the vehicle may avoid costs by removal of the vehicle or parts within 72 hours.  
(IC 9-22-1-11)

#### **§ 72.59 PREPARATION OF REPORT; PHOTOGRAPHS.**

If a vehicle or a part tagged under § 72.58 is not removed within the 72 hour period, the officer shall prepare a written abandoned vehicle report of the vehicle or parts, including information on the condition, missing parts, and other facts that might substantiate the estimated market value of the vehicle or parts. Photographs shall be taken to describe the condition of the vehicle or parts.  
(IC 9-22-1-12)

#### **§ 72.60 DISPOSITION OF VEHICLE OF LESS THAN ONE HUNDRED DOLLARS IN VALUE.**

If in the opinion of the officer the market value of an abandoned vehicle or parts determined in accordance with § 72.59 is less than \$500, the officer shall immediately dispose of the vehicle to a towing service. A copy of the abandoned vehicle report and photographs relating to the abandoned vehicle shall be forwarded to the state Bureau of Motor Vehicles. The towing service may dispose of the abandoned vehicle not less than 30 days after the date on which the towing service removed the abandoned vehicle. The public agency disposing of the vehicle shall retain the original records and photographs for at least two years.

#### **§ 72.61 DISPOSITION OF VEHICLE OF ONE HUNDRED DOLLARS IN VALUE OR MORE.**

(A) If in the opinion of the officer the market value of the abandoned vehicle or parts determined in accordance with § 72.59 is at least \$500, the officer, before placing a notice tag on the vehicle or parts, shall make a reasonable effort to ascertain the person who owns the vehicle or parts or who may be in control of the vehicle or parts.

(B) After 72 hours, the officer shall require the vehicle or parts to be towed to a storage yard or towing service.  
(IC 9-22-1-14)

#### **§ 72.62 VEHICLE ABANDONED ON RENTAL PROPERTY; NOTIFICATION PROCEDURES.**

(A) A person who finds a vehicle believed to be abandoned on the person's rental property shall do the following:

(1) Attach in a prominent place a notice tag containing the following information:

(a) The date, time, name and address of the person who owns the rental property and a telephone number to contact for information.

(b) That the vehicle is considered abandoned.

(c) That the vehicle will be removed after 72 hours.

(d) That the person who owns the vehicle will be held responsible for all costs incidental to the removal, storage, and disposal of the vehicle.

(e) That the person who owns the vehicle may avoid costs by removal of the vehicle or parts within 72 hours.

(2) Contact the state Bureau of Motor Vehicles to obtain the name and address of the person who owns the vehicle.

(3) Send, by certified mail, a copy of the information contained in the notice required under subsection (A) of this section to the person who owns the vehicle or parts.

(B) The notice required by division (A) of this section must be mailed to the person who owns the vehicle according to the records of the state Bureau of Motor Vehicles not later than five business days after receipt of the information in division (A)(2).

**§ 72.63 DISPOSITION OF VEHICLE ABANDONED ON RENTAL PROPERTY.**

If after 72 hours the person who owns a vehicle believed to be abandoned on rental property has not removed the vehicle from the rental property, the person who owns the rental property may have the vehicle towed from the rental property. The person who owns the rental property shall give the towing operator a copy of the certified letter required under § 72.62 as proof that notice of the towing has been given.

**§ 72.64 TOWING OPERATOR REQUIRED TO NOTIFY PUBLIC AGENCY AND STATE BUREAU OF MOTOR VEHICLES.**

**§ 72.65 VEHICLE ABANDONED ON PRIVATE PROPERTY; NOTIFICATION AND DISPOSITION PROCEDURES.**

Upon complaint of a person who owns or controls private property that a vehicle has been left on the property for at least 48 hours without the consent of the person who owns or controls the property, an officer shall follow the procedures set forth in §§ 72.58 through 72.61 (IC 9-22-1-18)

**§ 72.66 ABANDONED VEHICLE REPORT; FORWARDING TO STATE BUREAU OF MOTOR VEHICLES.**

(A) Within 72 hours after removal of an abandoned vehicle to a storage yard or towing service under §§ 72.60, 72.61 or 72.63, the public agency or storage lot shall prepare and forward to the state Bureau of Motor Vehicles an abandoned vehicle report containing a description of the vehicle, including the following information concerning the vehicle:

- (1) The make;
- (2) The model;
- (3) The identification number; and
- (4) The number of the license plate.

(B) The public agency or storage lot shall request that the state Bureau of Motor Vehicles advise the public agency or storage lot of the name and most recent address of the person who owns or holds a lien on the vehicle.

(C) Notwithstanding § 72.56 of this section, if the public agency or towing operator fails to notify the state Bureau of Motor Vehicles of the removal of an abandoned vehicle within 72 hours after the vehicle is removed as required by this section, the public agency or towing operator:

(1) May not initially collect more in reimbursement for the costs of storing the vehicle than the cost incurred for storage for 72 hours; and

(2) May collect further reimbursement under this subchapter only for additional storage costs incurred after notifying the state Bureau of Motor Vehicles of the removal of the abandoned vehicle.

**§ 72.67 DISPOSAL OF VEHICLE WITHOUT NOTICE.**

If a vehicle or parts are in such a condition that vehicle identification numbers or other means of identification are not available to determine the person who owns or holds a lien on the vehicle, the vehicle may be disposed of without notice.

**§ 72.68 TOWING AND SERVICE CHARGES.**

The owner of an abandoned vehicle is responsible for the abandonment and is liable, to the extent of the market value of the vehicle, for all of the costs incidental to the removal, storage, and disposal of the vehicle or the parts. The charge for towing and removing an abandoned vehicle shall not exceed \$250. The charge for storage shall not exceed \$50 per day and shall be limited to the actual days of storage. The vehicle shall be removed by an outside towing agency.

**§ 72.69 REMOVAL OF ABANDONED VEHICLES; ESTABLISHMENT OF PROCEDURES.**

To facilitate the removal of abandoned vehicles or parts, a public agency may employ personnel, acquire equipment, property, and facilities, and enter into towing contracts for the removal, storage, and disposition of abandoned vehicles and parts. The City Council may, by ordinance, establish procedures to carry out this section.

**§ 72.70 EXEMPT FROM LIABILITY.**

The following are not liable for loss or damage to a vehicle or parts occurring during the removal, storage, or disposition of a vehicle or parts under this chapter:

(A) A person who owns, leases, or occupies property from which an abandoned vehicle or parts are removed.

(B) A public agency.

(C) A towing service.

(D) An automobile scrapyard.

(E) A storage yard.

**ENFORCEMENT****§ 72.80 VIOLATIONS.**

If any motor vehicle is found parked, standing, or stopped in violation of the applicable provisions of this chapter or state law, the officer finding the vehicle shall record its registration number and any other information which may identify its owner. The officer shall affix a traffic citation to the vehicle in a conspicuous location. The citation shall be on a form provided by the Clerk-Treasurer and shall state that the owner must answer to the charge against him or her within five days, during the hours and at a place specified in the citation.

**§ 72.81 FAILURE TO COMPLY WITH TRAFFIC CITATION ATTACHED TO VEHICLE.**

If any vehicle owner does not appear in response to a traffic citation affixed to his or her vehicle within a period of five days, the Clerk-Treasurer shall send a letter to the owner of the motor vehicle to which the traffic citation was affixed informing the owner of the violation and warning the owner that if the charges stated in the citation are not answered to within five days following the date that the letter was mailed, an arrest warrant will be issued for the owner.

**§ 72.82 PRESUMPTIONS IN REFERENCE TO ILLEGAL PARKING.**

In any prosecution charging a violation of the parking provisions of this chapter, proof that the particular vehicle described in the complaint was parked in violation of the parking provisions of this chapter together with proof that the defendant named in the complaint was, at the time of the violation, the registered owner of the vehicle, shall constitute in evidence a prima facie presumption that the registered owner of the vehicle was the person who parked or placed the vehicle at the point where, and for the time during which, the violation occurred.

**§ 72.83 ABANDONED VEHICLES DECLARED A NUISANCE.**

The maintaining, placing, depositing, leaving, or permitting to be or remain on any public or private property an abandoned vehicle, as defined in § 72.55, is hereby declared to be and shall constitute a nuisance, and in addition to the other enforcement remedies set forth in this code the Building Inspector, Building Commissioner, Planning Director, Planning Commissioner, or any law enforcement officer may, in his or her sole discretion, cite a violation of § 72.55 through 72.70 directly into the City Court or other court of competent jurisdiction for enforcement of the violation. The penalty for the violation shall be in accordance with § 10.99 of this code.

### ***GENERAL PROVISIONS***

#### **§ 73.01 USE OF COASTER, ROLLER SKATES AND SIMILAR DEVICES RESTRICTED.**

No person upon roller skates or riding in or by means of any coaster, toy vehicle, or similar device shall go upon any roadway except while crossing a street on a crosswalk. When so crossing, that person shall be granted all the rights and be subject to all of the duties applicable to pedestrians. ('76 Code, § 7-13) (Ord. 1144, passed 2-7-83) Penalty, see § 73.99

### ***BICYCLES***

#### **§ 73.15 EFFECT OF BICYCLE REGULATIONS.**

(A) No person having custody or responsibility of or for any minor shall permit that minor to violate any provision of this subchapter.

(B) The provisions of this subchapter shall apply to any bicycle operated upon any street or upon any path set aside for the exclusive use of bicycles subject to those exceptions stated in this subchapter. ('76 Code, § 7-50) (Ord. 1144, passed 2-7-83) Penalty, see § 73.99

**§ 73.16 BICYCLE DEALERS.**

Every person engaged in the business of buying or selling new or second-hand bicycles shall maintain a record of every bicycle purchased or sold, giving the name and address of the person from whom purchased or to whom sold, a description of the bicycle by name or make, and its frame number. ('76 Code, § 7-51) (Ord. 1144, passed 2-7-83) Penalty, see § 73.99

**§ 73.17 TRAFFIC REGULATIONS APPLY TO PERSONS RIDING BICYCLES.**

Every person riding a bicycle upon a roadway shall be granted all of the rights and be subject to all of the duties applicable to the driver of a vehicle by this chapter, except as to regulations in this subchapter and those provisions of this chapter which, by their nature, can have no application. ('76 Code, § 7-52) (Ord. 1144, passed 2-7-83) Penalty, see § 73.99

**§ 73.18 PARKING.**

No person shall park a bicycle upon a street other than upon the roadway against the curb, or upon the sidewalk in a rack to support the bicycle, or against a building, or at the curb so that it results in the least obstruction to pedestrian traffic. ('76 Code, § 7-53) (Ord. 1144, passed 2-7-83) Penalty, see § 73.99

**§ 73.19 RIDING ON SIDEWALKS.**

(A) No person shall ride a bicycle, roller blades, in-line skates, skate boards or similar devices upon a sidewalk within a business district or Harrison Square Park.

(B) Any person riding a bicycle, roller blades, in-line skates, skate boards or similar devices shall yield the right-of-way to any pedestrian and give an audible signal before overtaking and passing the pedestrian. ('76 Code, § 7-54) (Ord. 1144, passed 2-7-83; Am. Ord. 1375, passed 6-2-97) Penalty, see § 73.99

**§ 73.20 RIDING ON ROADWAYS AND BICYCLE PATHS.**

(A) Every person operating a bicycle upon a roadway shall ride as near to the right side of the roadway as practicable, exercising due care when passing a standing vehicle or one proceeding in the same direction.

(B) Any person operating a bicycle shall use a bicycle path adjacent to the roadway, if that path has been provided and shall not use the roadway. ('76 Code, § 7-55) (Ord. 1144, passed 2-7-83) Penalty, see § 73.99



**§ 73.21 ATTACHING BICYCLES TO POLES.**

Any person may park near, and secure a bicycle to, any publicly owned pole or post for a period of not more than 12 consecutive hours, unless an official traffic control device or any applicable law or ordinance prohibits parking or securing bicycles at that location. No bicycle shall be secured to any tree, fire hydrant, or police or fire call box. No bicycle shall be secured so that it impedes the normal and reasonable movement of pedestrians or other traffic.

**§ 73.99 PENALTY.**

(A) Any person convicted of violating any of the provisions of this chapter for which no other penalty is set forth shall be subject to the provisions of § 70.99.

(B) Any person convicted of violating any provision of §§ 73.15 through 73.21 shall be fined not more than \$5, plus court costs. In addition, the bicycle of any person who violates any provision of said sections may be impounded for not more than 30 days. ('76 Code, § 7-57) (Ord. 1144, passed 2-7-83)

### SCHEDULE I: SPEED LIMITS.

It is hereby determined, upon the basis of traffic and engineering investigations, that the speed permitted by state law on the following streets or portions thereof is greater than is reasonable and safe under the conditions found to exist upon those portions. The maximum speed limit on these streets or portions thereof shall be 20 miles per hour.
