LEA shall conduct a Title I Parent Advisory Committee meeting at least twice a year for planning and evaluation of the Parental Involvement Plan/Policy.

LEA will involve the parents of children served in Title I schools in decisions about funds reserved for parent involvement through the Parent Advisory Committee.

Local schools shall encourage parents to attend Title I parent meetings and other school activities during the school year. Each school shall provide various school events to help build strong parental involvement. Announcements, flyers, parent letters, and parent sign-in sheets from parent events shall be kept on file at the district office. (events: open house, parent expo, grandparent's day, pancake/pajama night, parent reading night, fall festival, spaghetti supper, read across America, orientation, community night, family literacy night,)

Local school's personnel shall encourage parents to visit their child's school and talk with their child's teacher regularly.

Local schools shall provide opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children.

The LEA will provide written documents (such as parental involvement plan, compacts, newsletters etc.) in an understandable and uniform language and format, including alternative formats upon request, and, to the extent practicable, provide notice and the policy in a language the parents can understand.

CCS will use TransAct as an instrument to transfer documents in another language as requested. Also, CCS will provide a translator to interpret documents and/or procedures, including classroom assignments for ELL students and parents as needed.

Local schools shall submit to parents' procedures for filing comments/concerns to the LEA, if P.I. Plan, Title I Programs are not satisfactory. Parents are encouraged to contact the local school administration for assistance with filing a complaint. (See complaint procedures)

Local schools shall distribute monthly parental involvement newsletters offering practical ideas that promote school success and effective parenting tips. Newsletters are provided by the CCS Board of Education.

LEA will conduct annual meetings that will inform parents of their schools' participation in the Title I and to explain the rights of parents to be involved. The annual meetings will explain the purpose of the 1% set-aside funds for parental involvement and parents' right to be involved and how these monies are allotted for parental involvement activities.
