**Evaluation Committee recommends awarding the 21st Century CHAMPS Evaluator project to A.L. Burruss Institute of Public Service and Research at Kennesaw State University.**

While both Kennesaw State University and GA State University scored exactly the same on this RFP, the decision was made to award to Kennesaw State University because GA State University currently holds the DCSS contract for evaluating four other 21st Century Grant programs, while Kennesaw State University holds the DCSS contract for evaluating two other 21st Century Grant programs. Kennesaw State University held the contract for two previous 21st Century Grant programs until recently when those Grant Programs expired. Committee felt it would be equitable to award this new grant to Kennesaw State University so that each entity (GA State and Kennesaw) would be evaluating four grants each for DCSS.
