Douglas County School System to Implement Semi-Monthly Pay Periods

At the October 2, 2017, Board of Education work session, Dr. Michelle Ruble, Assistant Superintendent of Personnel and Policy, presented information on moving to semi-monthly pay periods for all school system employees beginning January 16, 2018.

The school system conducted an employee survey in September which showed that teachers favored a semi-monthly pay period by 62%, with new teachers in favor by an overwhelming 81%. The school system currently pays teachers and most other employees once a month. Since employees are paid on their last day before the holidays in December, they typically go five to six weeks before receiving their next pay check at the end of January.

"We want to accommodate our teachers and other employees by adjusting our pay periods," said Superintendent Trent North. "We consider this a recruiting and retention tool for our teachers. In most other professions, employees are paid semi-monthly, and we are happy to make this change since the survey shows that this is an important issue for members of our Douglas County School System family."
