### **Board Recognition**

#### **Fairplay Middle School**

The Fairplay Middle School softball team members and coaches were recognized for winning the 2017 Douglas County Softball Middle School Championship. This was the fourth year in a row that the Fairplay Lady Jags have won the championship. The team was undefeated during the 2016 and 2017 seasons.

#### **Stewart Middle School**

The Stewart Middle School football team members and coaches were recognized for winning the 2017 Douglas County Football Middle School Championship. The team was undefeated this season, and seven team members were named All County Award Winners.
