Dear Mr. Lightsey:

I would like to take this opportunity to formally thank you and the Department of Education for allowing us to participate in your 2003 Summer Conference. We believe that the Moving Kids Safely program offers valuable tools for any entity that may contract with motor coach operations for transportation. Our goal is for all highway users to reach their destinations and return home safely.

As we discussed at the Summer Conference, we have developed a report that lists the for-hire motor coach operations domiciled in Alabama that is registered with the U.S.D.O.T, Federal Motor Carrier Safety Administration (FMCSA) as of August 5, 2003. I am providing a hard copy of this report and will also forward to you via e-mail an electronic copy that you may post on the Department's website so that all Transportation Supervisors and any other interested parties (i.e. coaches, band boosters, teachers, PTA, etc.) may access it. Please feel free to share this information with anyone who may contract with a motor coach operation for transportation.

There are a few things that should be noted about this report. This report will contain information on all for hire motor coach operations that have registered with FMCSA as interstate carriers and have obtained a USDOT Number. Therefore, motor coach operations that operate wholly within the State of Alabama will not appear on this report.

The report reflects the status of these motor coach operations at a particular moment in time. As we discussed at the Summer Conference, there are a variety of websites available to the public which contain general and specific information about all transportation companies. It is imperative to use the websites for the most current information on the motor coach operations in conjunction with this report. In most cases, you can access the data on the websites with the motor coach's USDOT

number, MC number and/or the company name. These websites include:

I will provide an explanation regarding the column headings and general outline of the report. The “USDOT Number” column shows the DOT number assigned to a particular motor coach operation. This number and/or the company name can be used to access additional information from the websites discussed below.

The “Company Name/Address” column provides the information registered in the FMCSA computer system for the motor coach operation. The “Buses” column lists the number of buses that the motor coach has registered in the FMCSA system.

The “Safety Rating” column will list the most current Safety Rating issued to the motor carrier by the FMCSA. Ratings will be listed as S (Satisfactory), C (Conditional) or U (Unsatisfactory). Not all motor coaches have received a review by FMCSA and therefore not all have a Safety Rating. The Safety Rating column will be blank for “Unrated” motor coach operations.

1. A **Satisfactory** safety rating means that a motor carrier has in place and functioning adequate safety management controls to meet the safety fitness standard prescribed in 49 C.F.R. §385.5.
2. A **Conditional** safety rating means a motor carrier does not have adequate safety management controls in place to ensure compliance with the safety fitness standard that could result in occurrences listed in 49 C.F.R. §385.5 (a) through (k).
3. A motor carrier that receives an **Unsatisfactory** safety rating and does not improved their compliance status within an prescribed time frame is considered unfit to operate in interstate commerce and will be ordered to cease interstate operations.
4. **Unrated** means that a safety rating has not been assigned to the motor carrier by the FMCSA.

The “Last Review” column will give the date of the last review the FMCSA conducted of a particular motor coach operation. If there is no date in this column, then the motor coach has not been the subject of a Safety or Compliance Review by the FMCSA.

The “Safestat Score” column will reflect the carrier’s Safety Status as of August 5, 2003.

In general, there are four safety evaluation areas that make up a motor carrier’s Safestat score: Accident, Driver, Vehicle and Safety Management. These areas are assigned a score based up safety performance data and compliance history. These four scores are then input into the Safestat Algorithm to achieve their overall Safestat score and priority ranking. Motor carriers are grouped into priority categories A-H based upon their Safestat scores. Category A – B carriers are considered the highest risk carriers and are placed on the FMCSA priority list for a compliance review. Please refer to the Analysis and Information website for a detailed description of the Safestat program.

We hope that you and your customers will find the Moving Kids Safely program beneficial. The intent is to assist transportation decision makers in making the best educated decision for transporting Alabama’s school kids.
