1. CALL TO ORDER

The tentative budget hearing was called to order by the Chairwoman, Mrs. Audrey D. Lewis, at 6:00 p.m.

2. PUBLIC HEARING – Tentative Budget and Millage Rate

a. Approval of Resolution Number 20-01 for the Tentative Millage Rates for the 2020-2021 fiscal year

Following Mrs. Lewis reading of Resolution Number 20-01, she stated that the total millage rate to be levied is less than the roll-back rate computed pursuant to Section 200.065(1), F.S. by 4.17 percent. She stated that the Gadsden County School Board adopted each tentative millage rate for the fiscal year July 1, 2020 to June 30, 2021 on July 28, 2020 by separate vote prior to adopting the tentative budget.

The Board unanimously voted to approve Resolution Number 20-01 for the Tentative Millage Rates for the 2020-2021 fiscal year following Mr. Steve Scott's motion. The motion was seconded by Mr. Charlie D. Frost.
