School Board of Gadsden County, Florida CONTRACTUAL AGREEMENT Fiscal Year: 2011-2012

This contractual AGREEMENT is made between the <u>School Board of Gadsden County</u>, Florida, a school district, referred to as the "RECIPIENT", organized and existing under the laws of the State of Florida, with its principal place of business at 35 Martin Luther King., Jr. Blvd, City of Quincy, County of Gadsden, State of Florida, herein referred to as the Board, (also referred to as the District) and <u>Ms. Lisa Gaines</u>, a Registered Nurse with her principal place of business at <u>2986 Nutmeg Court</u>, <u>Tallahassee</u>, FL 32308 for the purposes of providing instruction to students in the Health Science Academy Program at East Gadsden High School (EGHS), herein referred to as "SUB-RECIPIENT". The contractual AGREEMENT will establish uniform administrative requirements for the SUB-RECIPIENT and the School Board of Gadsden County.

NOW, THEREFORE, the parties agree as follows:

ARTICLE 1. ENGAGEMENT OF THE SUB-RECIPIENT

The RECIPIENT agrees to engage the SUB-RECIPIENT and the SUB-RECIPIENT agrees to perform the functions as outlined in her proposal to the Principal of EGHS and Director of School Improvement at EGHS to provide instructional services to students at EGHS in Gadsden County as further set forth below. The SUB-RECIPIENT understands and agrees that all services contracted are to be performed solely by the SUB-RECIPIENT and her certified experienced training staff and may not be subcontracted for or assigned without the prior written consent of the RECIPIENT.

The RECIPIENT and SUB-RECIPIENT understand and agree that this AGREEMENT is valid only if approved and funds awarded for the same to Gadsden County by the Florida Department of Education. In addition, the RECIPIENT and SUB-RECIPIENT understand and agree that continuation of this AGREEMENT through 2011 is contingent upon continued funding of the grant by the Florida Department of Education to Gadsden County.

ARTICLE 2. SCOPE OF SERVICES

SUB-RECIPIENT agrees to:

- Teach a 55 minute Medical Skills and Services class once a day for the Health Science Academy at EGHS, including classroom instruction and hands-on training;
- Write lesson plans for classes;
- Collaborate with other faculty and staff in school to monitor student progress in other classes;
- Bring in speakers to discuss health care career options with students;
- Conduct parent conferences;
- Attend department meetings;
- Attend faculty meetings;
- Research grant opportunities to locate funding to sustain the program;
- Administer standardized tests, if needed;
- Create Industry Advisory Board consisting of health care leaders throughout the North Florida Region; and
- Collaborate with STRIDE to plan field trips.

- · Organize and advise Health Occupations Students of America, Inc. Chapter
- Any changes to the Services must be made by mutual AGREEMENT in writing. The SUB-RECIPIENT'S Principal Contact for the services will be <u>Ms. Lisa Gaines</u>.

ARTICLE 3. DURATION OF AGREEMENT

(a). This AGREEMENT shall begin on the week of August 22, 2011 and end no later than June 30, 2012 (including any award ceremonies) contingent upon the approval and funding by the Florida Department of Education as stated in Article 1 above. As required by law, this AGREEMENT shall be subject to annual review and renewal if funding permits.

(b). SUB-RECIPIENT shall begin performing the contract on the week of August 22, 2011 and finish the project by no later than June 30, 2012 (including any award ceremonies).

ARTICLE 4. DEFINITIONS

Term	Definition

RECIPIENT	means an organization receiving financial assistance directly from the Department of Education to carry out a project or program. The term includes public and private institutions of higher education, public and private hospitals and other quasi-public and private non-profit organizations such as, but not limited to, community action agencies, research institutes, educational associations, and health centers.
SUB- RECIPIENT Sub-award	means the legal entity to which a sub-award is made and which is accountable to the RECIPIENT for the use of the funds provided. means an award of financial assistance in the form of money, or property in lieu of money, made under an award by a RECIPIENT to an eligible sub- RECIPIENT or by a sub-RECIPIENT to a lower tier SUB-RECIPIENT. The term includes financial assistance when provided by any legal AGREEMENT, even if the AGREEMENT is called a contract, but does not include procurement of goods and services nor does it include any form of assistance

ARTICLE 5. PAYMENT

RECIPIENT shall pay the SUB-RECIPIENT upon the receipt of monthly invoices from (a). the SUB-RECIPIENT that includes documentation describing the services that were rendered by the SUB-RECIPIENT in support of the project for the period that the invoice covers. Invoices will require a minimum of fourteen (14) days to be processed for payment after an invoice has been approved for payment by School Board of Gadsden County. In full and complete compensation for all services provided by SUB-RECIPIENT under this AGREEMENT, RECIPIENT shall pay to Ms. Lisa Gaines the amount of \$24,300.00. Ms. Lisa Gaines will invoice the RECIPIENT monthly in the amount of no more than \$2,430.00 per month for 10 months of services provided. Invoices shall be prepared and addressed to: Rose Raynak, Director of Federal Programs at 35 MLK Jr. Blvd. Room 24B, Gadsden County School District, Quincy, Florida 32351. The RECIPIENT shall pay SUB-RECIPIENT within fourteen (14) days of receipt of SUB-RECIPIENT'S invoice. Checks shall be made payable to Ms. Lisa Gaines and presented to Ms. Lisa Gaines. The invoices will be sent in by the 15th of each month and will be payable on the last day of the month. The invoices will document the services provided, including time/effort log monthly, agendas and minutes of all meetings and workshops/activities (including parent conferences, guest speakers, HOSA meetings, Advisory Board meetings, faculty and department meetings, faculty/staff meetings monitoring student progress), sign in sheets (for every meeting and/or workshop/activity), curricula developed, grant opportunities found and applied for, projected outcomes, and any other content material or lesson plans developed.

(b). The SUB-RECIPIENT shall not pledge the RECIPIENT'S credit or make the RECIPIENT a guarantor of payment or surety for any contract, debt, obligation, judgment, lien, or any form of indebtedness.

(c) The total cost of the AGREEMENT is \$24,300 (\$45 per hour x 15 hours per week x 36 weeks).

(d) In the event it becomes necessary for SUB-RECIPIENT to commence collection proceedings or retain an attorney to enforce any of the terms of this AGREEMENT, the district shall pay attorneys' fees and the costs of collection incurred by SUB-RECIPIENT.

ARTICLE 6. PUBLIC RECORDS

Where applicable, documents prepared pursuant to this AGREEMENT may be subject to Florida's Public Records Law. Refusal of the SUB-RECIPIENT to allow public access to such records shall constitute grounds for cancellation of this AGREEMENT.

ARTICLE 7. ACCESS AND RETENTION OF RECORDS

The RECIPIENT shall have access to all SUB-RECIPIENT'S records that are directly pertinent to this AGREEMENT. The SUB-RECIPIENT shall retain all required records for five (5) years after the RECIPIENT makes the final payment and all other pending matters are closed. The SUB-RECIPIENT shall maintain accurate, current, and complete disclosure of all financial

and/or activity results/records of the project in accordance with established Federal and District requirements

ARTICLE 8. TERMINATION OF AGREEMENT

The parties hereto contemplate this contract to run for the duration of the grant award subject to annual review and renewal as required by law. Any party wishing to terminate this contract prior to its expiration date shall provide the other party with sixty (60) days written notice. Upon termination, the district shall be responsible for payment of all costs incurred by SUB-RECIPIENT in the performance of the AGREEMENT prior to termination.

ARTICLE 9. AMENDMENTS

Any changes must be mutually agreed upon and incorporated in written amendments to this AGREEMENT.

ARTICLE 10. INDEPENDENT SUB-RECIPIENT

The SUB-RECIPIENT is an independent agent and not an employee or agent of the RECIPIENT. SUB-RECIPIENT agrees to comply with all requirements of the Jessica Lunsford Act. SUB-RECIPIENT shall be acting as independent SUB-RECIPIENT in the performance of this AGREEMENT, and shall be responsible for the payment of claims for loss, personal injury, death, property damage, or otherwise arising out of any act or omission of their respective employees or agents in connection with the performance of the Services for which they may be held liable under applicable law. Each party shall maintain at its sole expense adequate insurance or self-insurance coverage to satisfy its liability obligations under this AGREEMENT.

ARTICLE 13. AGREEMENT AS INCLUDING ENTIRE AGREEMENT

This AGREEMENT supersedes all previous oral or written communications, representations or AGREEMENTS on this subject. CONFLICT OF INTEREST: As of the date of this AGREEMENT, SUB-RECIPIENT is not a party to any oral or written contract or understanding or legal or regulatory obligation that will in any way limit or conflict with its ability to fulfill the terms of the AGREEMENT.

The Office of Management and Budget (OMB) has withdrawn the SF-269 from use and the Department of Health and Human Services (HHS) intends to modify 45 CFR parts 74 and 92 to reflect that change. 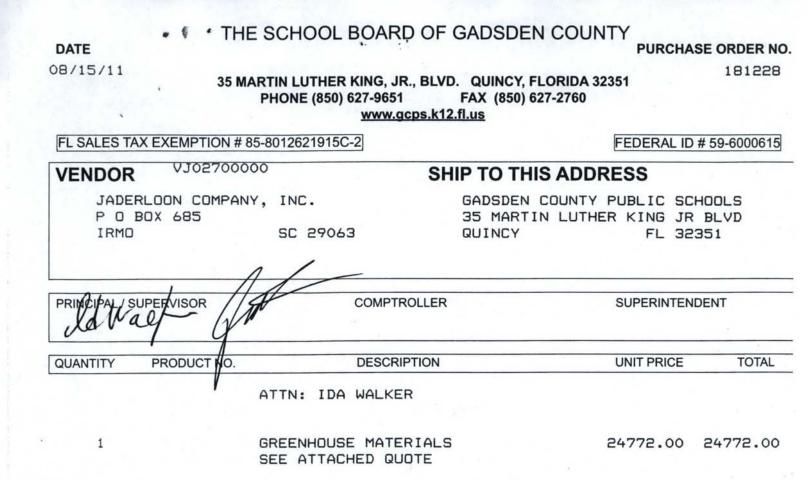

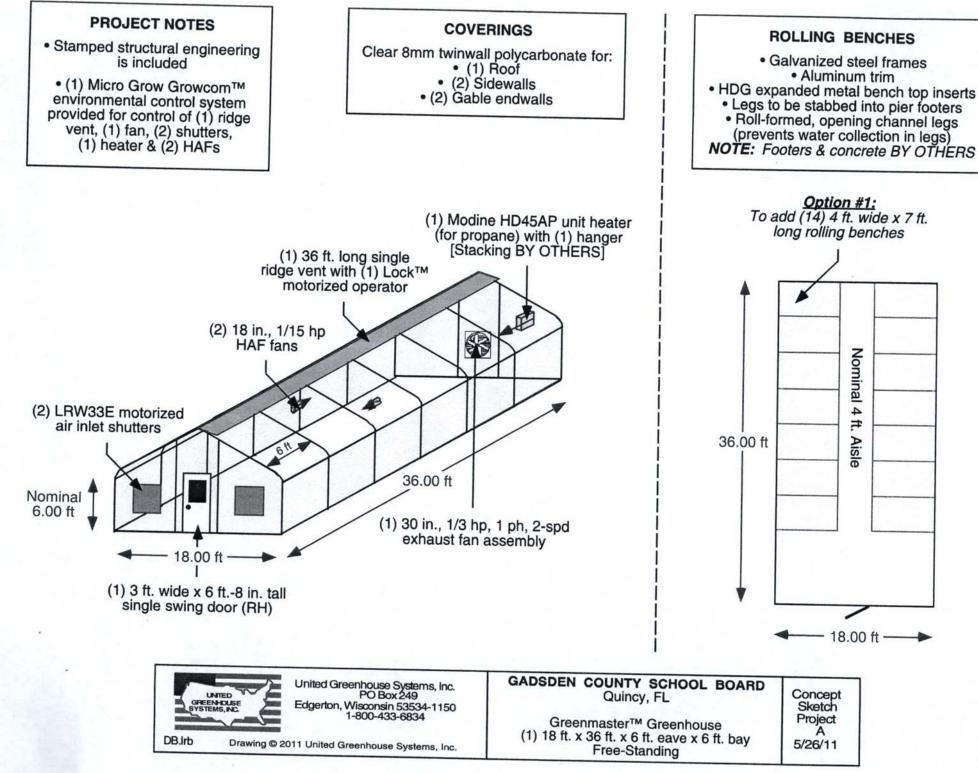
