SCHOOL BOARD WORKSHOP

This workshop was open to the public and electronically recorded.

The following Board members were present: Mr. Isaac Simmons, Chairman; Mr. Roger P. Milton; Mr. Judge B. Helms; and Mr. Eric F. Hinson. Also present were Mrs. Deborah Minnis, Attorney for the Board; and others. Mr. Charlie D. Frost; and Mr. Reginald C. James, Superintendent and Secretary to the Board were absent.

1. CALL TO ORDER

The workshop was called to order by the Chairman, Mr. Isaac Simmons, at 4:34 p.m.

2. FINANCIAL DATA REPORT

Mrs. Wood shared with the Board the following information: 1) Student WFTE Survey Sheet for the 2009 – 2010 year; 2) 110 - General Fund – Encumbered \$3,125,341.16; 3) 300 - Capital Projects Fund – Encumbered \$792,105.03; 4) 410 - Food Service Fund – Encumbered \$226,262.87; 5) 420 - Contracted Projects Fund – Encumbered \$925,436.52; 6) 431 - State Fiscal Stabilization Fund; 7) 432 - Targeted ARRA Stimulus Fund – Encumbered \$38,737.02; and 8) 433 - Other ARRA Stimulus Grants – Encumbered \$23,378.74.

Mrs. Wood and Mrs. Amy O'Donnell (Secretary, Maintenance Department) shared with the Board a power-point presentation outlining the following district data-driven decisions: a) population by cities; b) population estimates by cities including the unincorporated Gadsden County: c) 2000 Gadsden County population density; d) annexations from 2006 – 2008; e) capital outlay FTE; f) Gadsden County population increasing slowly 2000 – 2001 estimates; g) elementary school attendance zones and FTE; h) gender demographics for grades K - 5th; i) middle school attendance zones and FTE; j) gender demographics for grades $6^{th} - 8^{th}$; k) high school attendance zones and FTE; l) gender demographics for grades $9^{th} - 12^{th}$; m) other sources of FTE; n) homeless information; o) free or reduced breakfast and lunch; p) pregnancy and parents; q) exceptional student education; r) English for speakers or other languages; s) migrants; t) No Child Left Behind School Choice Options; u) comparison of state/local revenue to federal revenue; v) Gadsden County student population; w) missing student locations; x) facility capacity vs. enrollment; and y) comparison of facility capacity and current FTE for middle and high schools.

The Board members asked questions, shared their concerns, and made comments during the power-point presentation outlining the district data-driven decisions. The Board thanked Mrs. Wood and Ms. O'Donnell for sharing the power-point presentation with them.
