
We are building a state-of-the-art, \$21 million Head Start center in Atlantic City that will make our program better and be an economic boost and a beacon of hope as well.

Head Start turns Sandy's wrath into new beginning in Atlantic City

uperstorm Sandy ravaged the New Jersey and New York coastlines in the Fall of 2012, destroying towns and cities, sweeping away homes and public properties, displacing countless numbers of families and causing billions of dollars of damage. Atlantic City was among the hard hit, suffering economically and emotionally from the wrath of the storm. The city's Head Start program was not spared, as Sandy severely damaged four Head Start centers, causing five centers to be reduced to two.

But something great is happening in Atlantic City coming out of a terrible tragedy. The Gateway Head Start Early Education Center, providing a state-of-the-art early educational experience, will rise in the heart of Atlantic City through funding from Superstorm Sandy Relief funds coordinated through Head Start Region II.

Plans and an architect's renderings were revealed in a groundbreaking ceremony at the Bacharach Boulevard site on May 19, 2015. Construction is underway and the center will open in 2017.

The new three-story center, 43,747 square feet, will have 20 classrooms for about 300 Head Start and Early Head Start students. The \$21-million center will feature two Head Start playgrounds and one Early Head Start playground. The administrative floor will have an emergency services room (showers, washers and dryers), a cooking kitchen, offices, cubicles, a meeting/ training room and generator room. It will be a haven for Atlantic City's child education, family resources and a hub of community activities.

The children currently attending Head Start and Early Head Start in three centers in Atlantic City will be moved to this site.

About 200 attended Gateway Community Action Partnership's groundbreaking ceremony, including Gateway senior management, Gateway staff, U.S. Dept. of Health and Human Services staff and elected officials.

"One way we can have greatness for our children is what you see here," said Albert B. Kelly, Gateway's President and CEO, as he

pointed to an artist's rendering of the center. "A beautiful spanking brand new Head Start center situated right here in the heart of Atlantic City. We have to plant the seeds today for their greatness tomorrow, and this is one way to do it. We are going to do what we have to do to provide greatness for our children to move ahead. Our children deserve nothing less than our best. Not just our good intentions, not just our good attempt, not just some good idea. Our children deserve greatness. From this tragedy will be transformation and great triumph."

Head Start Program celebrates 50 years



Gateway Community Action Partnership's Head Start program joined Head Start programs nationwide in celebrating the 50th anniversary of the program on May 18 by planting rose bushes.

These rose bushes signify the beginning of the program, when former President Lyndon B. Johnson signed the Head Start Act on May 18, 1965 in the White House Rose Garden.

Gateway Head Start children and staff planted rose bushes at the River's Edge Community Campus in Bridgeton, the John O. Wilson Hamilton 1 Head Start Center in Hamilton, and at the Mayor Usry Center in Atlantic City.

WIC program selected as Atlantic County grantee

ateway Community Action Partnership assumed sponsorship of the Atlantic County's Women Infants and Children (WIC) Program in October 2015 with expanded hours and new facilities to better serve county residents.

Gateway, with more than two decades of experience administering the WIC program in South Jersey, was selected by the New Jersey Department of Health's Division of Family Health Services to replace the Atlantic City Health and Human Services Department.

Atlantic City officials relinquished operation of the countywide WIC program as part of an effort to increase efficiencies and balance the City's 2016 budget. City officials said the move will save city's taxpayers thousands of dollars, while continuing to provide this necessary and important program to all Atlantic County residents.

"First and foremost, my concern is that our residents receive the best possible care, especially our young mothers and children," said Atlantic City Mayor Donald A. Guardian. "I have the utmost confidence in Gateway's experience and passion for taking care of people who need it the most. I know Gateway will make a positive difference for our Atlantic City residents, and I look forward to partnering with them for many years to come."

Gateway Community Action Partnership currently serves approximately 22,000 WIC clients in Camden, Cape May, Cumberland and Salem counties.
