The District shall have the option to automatically renew the Contract, annually, in yearly increments for a maximum for two (2) consecutive years after the initial Contract year. Contract renewals and extensions are not guaranteed and shall be dependent on the availability of funding and your performance under the Contract.

**The Contract commencement date shall be July 1, 2018**, provided the District has not rescinded the Notice of Intent or placed a stay on commencement pending the outcome of any protest. This Notice, along with your Bid submission, the solicitation documents and any addenda or documents in the solicitation shall be the full agreement between you and the District unless amended in writing by the District. Your acceptance of the Notice of Intent to Award serves as acceptance of the Contract and all conditions. Any changes to the Contract conditions must be in the form of a Change Order and acknowledged by both parties.
