CALL TO ORDER President Othmer called the meeting to order at 6:30 p.m.

PUBLIC HEARING

Mr. Othmer and Mr. Berry opened the session. The code of conduct is changing due to prohibition of electronic cigarettes.

The building principals Mrs. Hayes and Mr. Cronin presented the attached statistics on student attendance and discipline for each level. Mr. Baker noted the high school has an attendance rate of 94.27% with 15 students with 20 or more absences. The internal and external (PINS) interventions were explained to the board. There was a discussion on bullying.

7310, Prohibited Student Conduct (One section only)

This section of the code of conduct has been updated to allow the board to establish a prohibition on the use of electronic cigarettes (simulates smoking; can contain nicotine).

3410, Public Conduct on School Property

This section of the code of conduct has been updated also to establish the prohibition on the use of electronic cigarettes.

There were no additional board comments.

There were no public comments on the change in code of conduct.

PRESENTATION/DISCUSSION/ADMINISTRATIVE COMMENTS

Discussion on proposed Costa Rica trip information – Mr. Wayne Strong gave an overview of the documents shared with the board on the proposed trip to Costa Rica for Spanish, French and MOAS students. The board was receptive to the trip with the only cost to the district being chaperones for the trip.

Budget Presentation – Mr. Berry and Mr. Hilker presented the two attached presentations regarding budget history and the current status of the 2014-2015 budget development. The recommended tax levy is 2% with direction from the board. State aid is currently at \$230,000 yet the governor's budget is not yet finalized. To close the gap for the budget can come on one of three ways 1) use of fund balance 2) use of reserves or 3) by cutting staff.

Mr. Berry referred to the Triborough amendment in the law and the inaccuracy of The Post Star article regarding teacher contracts.

- 2) Grades seven and eight shall be moved to the current elementary school; and the elementary/high school will change its name to Hadley-Luzerne Junior/Senior High School.
- 3) The current elementary school (NYSED BEDS number 630801040002) will close and move its students to the Stuart M. Townsend School and the building will now be reconfigured as part the Hadley-Luzerne Junior/Senior High School

BE IT FURTHER RESOLVED, the Hadley-Luzerne Central School Board of Education approves for submission the NYSED required documentation inclusive of District Summary Form, Modification of Registration due to a New Grade Configuration, and School Impact Forms.

NOTICE IS HEREBY GIVEN, that a Public Hearing on the proposed 2014-2015 Budget for the Hadley-Luzerne Central School District shall be held in the Middle School Large Group Instructional Room of the Hadley-Luzerne Stuart M. Townsend Middle School, 27 Hyland Drive Lake Luzerne, New York, on Monday, May 12, 2014 at 6:30 p.m., prevailing time. Copies of the budget will be available for review commencing on May 5, 2014 at the District Office, School Business Office and the main office of each school building between the hours of 8:00 a.m. and 3:30 p.m. Monday through Friday.

AND FURTHER NOTICE IS HEREBY GIVEN, that the annual meeting of the qualified voters of the Hadley-Luzerne Central School District, will be held on Tuesday, May 20, 2014 between the hours of 12:00 noon and 8:00 p.m., prevailing time, at the Stuart M. Townsend Middle School, 27 Hyland Drive, Lake Luzerne, New York, at which time the polls will be opened to voting by machine or ballot on the following items:

- 1. To adopt the annual budget of the Hadley Luzerne Central School District for the fiscal year 2014-2015 and to authorize the requisite portion therefore to be raised by taxation on the taxable property of the District.
- **2.** To elect one (1) member to the Board of Education to a three (3) year term, commencing on July 1, 2014 and expiring on June 30, 2017.
- **3.** To adopt the following proposition(s):

PROPOSITION I – CAPITAL PROJECT FUNDING FOR BUILDING AND GRADE LEVEL RECONFIGURATION

WHEREAS, the Board of Education, has for the past two years, studied options for improving the delivery of education and services provided to the students of the Hadley-Luzerne Central School District; and

WHEREAS, the Superintendent of Schools and the Board of Education have involved and invited community groups to participate in discussions, open forums and other meetings relating to the movement of Pre-kindergarten through grade 2 students to the current middle school and moving seventh and eighth grade students to the current elementary wing located adjacent to the Hadley-Luzerne High School; and

WHEREAS, the reconfiguration of grades will result in Pre-kindergarten through grade six receiving their educational program and services at the renamed Stuart M. Townsend Elementary School located at 27 Hyland Drive, Lake Luzerne, NY; and

WHEREAS, the reconfiguration of grades will result in seventh and eighth grade students receiving their educational program and services at the renamed Hadley-Luzerne Junior-Senior High School located at 273 Lake Avenue, Lake Luzerne, NY; and

WHEREAS, the reconfiguration of grades will result in the closure of the previously known Prekindergarten through grade two elementary school located adjacent to the Hadley-Luzerne High School located at 273 Lake Avenue, Lake Luzerne, NY; therefore,

SHALL the Board of Education of the Hadley Luzerne Central School District be authorized to transfer \$375,000 from the general fund balance and to place any revenue, not required by law to be paid into any other fund or account, into a Capital Project Fund (adding to the \$160,000 currently authorized'), and to expend such sums for the purpose of building and grade level reconfiguration in an amount not to exceed \$535,000?

PROPOSITION II – TWO SCHOOL BUSES

RESOLVED, that the Board of Education is hereby authorized to acquire two (2) 66 passenger school bus at a maximum estimated cost not to exceed \$230,000, which is estimated to be the maximum cost thereof, and to expend such sum for such purpose and to levy the necessary tax therefore taking into account state aid received, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, issue bonds and notes of the District at one time or from time to time in the principal amount not to exceed \$230,000 and to levy a tax to pay the interest on such obligations when due.

PROPOSITION III – ONE MINI VAN

RESOLVED, that the Board of Education is hereby authorized to acquire one (1) minivan at a maximum estimated cost of approximately \$25,000 and to expend such sum for such purpose and to levy the necessary tax therefore taking into account state aid received, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, issue bonds and notes of the District at one time or from time to time in the principal amount not to exceed \$25,000 and to levy a tax to pay the interest on such obligations when due.

4. To transact such other business as may properly come before the meeting pursuant to the Education Law of the State of New York.

The election and budget vote shall be by machine or absentee ballot. The hours during which the polls shall be kept open shall be from 12:00 noon to 8:00 p.m. prevailing time or for as long thereafter as necessary to enable qualified voters who are in the polling place at 8:00 p.m. to cast their ballots.

AND FURTHER NOTICE IS HEREBY GIVEN, that a copy of the statement of the amount of money which will be required to fund the School District's budget for the 2014-2015 school year, exclusive of public monies, may be obtained by any resident of the District during business hours beginning Monday, May 5, 2014 at the School Business Office and the Main Office of each school building between the hours of 8:00 a.m. and 3:30 p.m., prevailing. Copies shall also be available at the Annual District Meeting.

AND FURTHER NOTICE IS HEREBY GIVEN, that petitions nominating a candidate for the office of member of the Board of Education to fill one (1) expired term of three (3) years, must be filed with the Hadley Luzerne District Clerk at the Superintendent's office, not later than April 22, 2014 between 9:00 a.m. and 5:00 p.m. Each petition must be directed to the District Clerk, must be signed by at least 25 qualified voters of the District or 2% of the registered voters of the District who voted in the previous annual election, whichever is greater and must state the name and residence of the candidate that shall fill the vacancy "At Large". A copy of such petition may be obtained at the Office of District Clerk, Stuart M. Townsend Middle School, 27 Hyland Drive, Lake Luzerne, during regular school hours.

AND FURTHER NOTICE IS HEREBY GIVEN, applications for absentee ballots for election of Board Members and voting on the budget and propositions may be applied for at the Office of the District Clerk between the hours of 8:00 a.m. and 4:00 p.m. Monday through Friday, except holidays. Completed applications for absentee ballots must be received by the District Clerk at least seven (7) days prior to the vote if the ballot is to be mailed to the voter, or the day before the election, if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the District Clerk not later than 5:00 p.m. on May 20, 2014. A list of all persons to whom absentee ballots shall have been issued will be available in said office of the District Clerk at the Stuart M. Townsend Middle School, on each of the five days prior to the

day of the election, except Sunday, May 18, 2014, and only by appointment on Saturday, May 17, 2014. Any qualified voter may challenge the acceptance of the ballot of any person on such list, by making his/her challenge and reasons therefore known to the Chief Inspector of Election before the close of the polls.

AND FURTHER NOTICE IS GIVEN, that personal registration of voters is required either pursuant to Section 2014 of the Education Law or pursuant to Article 5 of the Election Law. If a voter has already registered pursuant to Section 2014 of the Education Law and has voted at an annual or special district meeting within the last four (4) calendar years, he or she is eligible to vote at this election; if a voter is registered and eligible to vote under Article 5 of the Election Law, he or she is also eligible to vote at this election. All other persons who wish to vote must register.

Personal registration for all qualified voters of the District pursuant to Education Law shall occur at the District Office, Stuart M. Townsend Middle School, 27 Hyland Drive during business hours of the school, but no later than May 15, 2014, at which time any person will be entitled to have his or her name placed on the Register, provided that during such registration, the prospective voter is known or proven to the satisfaction of the District to be then or thereafter entitled to vote at such election for which the register is prepared.

Please take further notice that the register prepared pursuant to Section 2014 of the Education Law shall be filed in the Office of the District Clerk; that such register shall be open for inspection by any qualified voter of the District, on each of five days prior to the day of the election, except Sunday, May 18, 2014, and that the hours during which such register shall be open for inspection shall be from 8:00 a.m. to 3:30 p.m., prevailing time and by appointment on Saturday, May 17, 2014.

AND FURTHER NOTICE IS HEREBY GIVEN that pursuant to Section 2014 of the Education Law of the State of New York, the Board of Registration will meet during the annual meeting, at the Stuart M. Townsend Middle School in the Town of Lake Luzerne, Warren County, New York, to prepare the Register of the School District to be used at any special district meetings that may be held after the preparation of said Register, or placed on such Register provided that at such meeting of said Board of Registration he/she is known or proven to the satisfaction of such Board of Registration to be then or thereafter entitled to vote at the school election for which said Register is prepared, or any special district meeting held after May 20, 2014.
