CALL TO ORDER

President Othmer called the meeting to order at 6:30 p.m.

PRESENTATION/DISCUSSION/ADMINISTRATIVE COMMENTS

2014-2015 Proposed Budget and Reconfiguration Presentation/Discussion

PUBLIC HEARING: 2014-2015 PROPOSED BUDGET

Board/Administrative Comments – There were discussions on the reconfiguration, administrative leadership, playground, playground funding, and fund amount.

Public Comments – Bill Cartier of Hadley noted that student enrollment is less, expressed concern over the Star application process, questioned the number of teachers, cost per student, why we are not reducing the admin staff. Karl Othmer answered that these opportunities for cost saving will present themselves in the future, but at this time the reconfiguration is not approved.

Stan Goldberg of Lake Luzerne asked how bullying is handled in the school, including repeat offenders. Paul Berry explained the utilization of a school counselor. Each principal explained the character education programs in their building and the steps taken when addressing bullying.

Duane Moulton of Lake Luzerne reminded all of the audit report last year which scolded the district for tax payers not receiving a benefit from the excessive fund balance, but the board at that time, decided not to give the funds back due to the 5 year plan in place, and instead set the reserves. Now is the time with the additional funds to move ahead with the reconfiguration and while the reserves are still fully funded; he did note that the current trend of increasing the budget by 800,000 is not sustainable. Loosing state aid will result in positions needing to be cut. If the reconfiguration is complete there will be opportunities for cuts but those cuts will still need to be made even if the reconfiguration does not pass.

Carol Gorham of Lake Luzerne stated that what she doesn't agree with is what it is going to cost (for reconfiguration). She questioned why we need science labs, when there are usable rooms available. "Just because you budget something doesn't mean you have to spend it. Reconfiguration can happen without all this expense." Karl Othmer answered that there were extensive Building and Grounds Committee meetings with all parties involved and this was the result of those meetings, the available rooms would be pushed beyond 100% capacity and this is an opportunity to be attractive to incoming families.

Gary Powers of Lake Luzerne stated it is dangerous if voted down and it will be another 20 years and the opportunities are needed now.

Bill Cartier of Hadley stated that the cost in 2003 was over 1 million dollars to reconfigure the buildings and this is a savings so this vote should pass and there is value in this reconfiguration.
