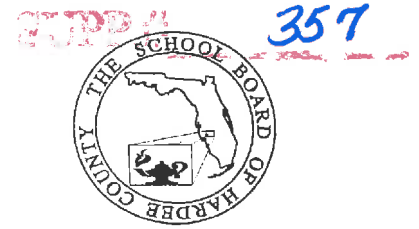

**Subject:** Agreement with Alternative Behavioral Concepts, Inc. and the School Board of Hardee County for the 2018-2019 year.

**Background Information:** The purpose of this Agreement is to provide behavioral observations and development of behavioral intervention plans for students with disabilities in Hardee District Schools. Alternative Behavioral Concepts, Inc. will also provide training for staff on implementation of behavior plans and behavior management strategies.

## **Alternative Behavioral Concepts, Inc.**

### **BCBA:**

The provider will complete Functional Behavioral Assessments to include behavioral observations, interviews, and development of Behavioral Intervention Plans for individual students per request of the Director of Exceptional Student Education and/or designee.

A final written report will be completed and submitted to the Director within thirty (30) business days of receipt of referral for behavioral services.

The provider will participate and/or present a summary of the assessment and recommended interventions at planning meeting upon request of the director of Exceptional Student Education and/or designee.

The provider will train staff on implementation of the individual behavior plans, train behavior management strategies, train progress monitoring and provide hands on technical assistance to staff.

### **BCABA:**

Staff training will be outcome based and provided by the BCABA

The provider will train staff on implementation of the individual behavior plans, train behavior management strategies, train progress monitoring and provide hands on technical assistance to staff.

A final written report will be completed and submitted to the Director within thirty (30) business days of receipt of referral for behavioral services.

The provider will participate in planning meeting upon request of the Director of Exceptional Student Education.

Alternative Behavioral Concepts, Inc. agrees to have staff sign in and out at each school site visited so that an accurate accounting of time is available for review. Time sheets with the date and names of students served and the type of services must be submitted monthly with request for payment. Reimbursement for services will be provided only on request made by the Director of Exceptional Student Education and/or designee.

**Service Agreement**

**School Board of Hardee County and

This service agreement dated the 28th day of June, 2018, by and between THE SCHOOL BOARD OF HARDEE COUNTY, FLORIDA, and Alternative Behavioral Concepts, Inc.

WHEREAS, Alternative Behavioral Concepts, Inc. is approved by The School Board of Hardee County to perform the following Consultative Services at Hardee County Schools under the direction of the Director of Exceptional Student Education, July 2, 2018 through June 28, 2019.

Consultative Services from a Board Certified Behavior Analyst (BCBA) are to be paid at \$100 per hour. Services from a Board Certified Assistant Behavior Analyst (BCABA) or equivalent are to be paid at \$75 per hour. Registered Behavior Technician (RBT) to be paid at \$35 per hour. Professional Crisis Management (PCM) Certification provided at a cost of \$142.90 per person (training and manual); PCM Recertification at the cost of \$127.50 per person (training and manual). Services are not to exceed \$40,000.00.

Payment shall be made upon receipt of invoice for professional services within 30 days.
