Background Information: In the 2012-2013 and 2013-2014 school years we piggybacked the Collier County School Board, bid #114-6/10 with Borden Dairy for the purchase of milk and other dairy products for the school food service program. Collier County has renewed the bid with Borden Dairys. Borden has again permitted us to piggy back the Collier bid.

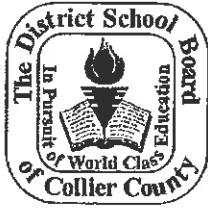
