Subject: Hilltop Elementary Playground Cover Contract

Background Information: At the School Boards direction, we were given permission to advertise for bids on this project on February 9, 2015. We did so in the Herald Advocate on February 26, 2015, and then conducted a pre-bid meeting on March 11, 2015. All though the advertisement was E-mailed to several contractors, E.O. Koch Construction Company was the only attendee.

After the pre-bid meeting, we negotiated terms and conditions with E.O. Koch Construction, revising the cover size (60' x 100'), clarifying that the cover will be open without a skirt wall, and allowing a direct-to-metal industrial enamel latex paint instead of an alkyd paint.

Their proposal is for \$146,191, which is \$12,809 below our estimated budget. Having worked with them on the batting cages, which was a similar project, and the Stadium press box renovation last year I am confident in their ability to complete this project to our satisfaction. I therefore ask your permission to award this contract to E.O. Koch Construction.


Administrative Consideration (include F.S., Rule, Authority, etc.): State Board of Education Rule 6A-1.012(12)(c)- If less than two responsive proposals for commodity or contractual services are received, the district school board may negotiate on the best terms and conditions or decide to reject all proposals. The district school board shall document the reasons that negotiating terms and conditions with the sole proposer is in the best interest of the school district in lieu of resoliciting proposals.




