Subject: Approval of Pest Control Services Contract

Background Information: At the regular Board meeting December 9, 2019 it was decided to go out for bid for continuing services for pest control. At the next regular meeting January 9, 2020 I asked for permission to advertise for this service. On January 15, 2020 it was advertised in the Lakeland Ledger, and on January 16, 2020 it was advertised in the Herald Advocate.

On January 27, 2020 a pre bid meeting was held, and three contractors attended. The specifications were distributed, and all questions answered. A tour of the facilities was offered after that meeting. Bids were opened on February 10, 2020, and all three responded. Florida Pest Control was the low bidder at \$2460.00, Cox Pest Control was second at \$2557.50, and Joe Vessels Pest Control was the high bidder at \$2600.00.


We therefore recommend that you award this contract to Florida Pest Control, to begin March 1, 2020 for the remainder of FY 2019-20 and FY2020-21.
