**HVAC & Controls Services Contract** 

**Background Information**: At the School Board Meeting of April 11, 2013 I asked and received permission to advertise for bids on this contract for service. We conducted a pre bid meeting with six interested contractors on May 20, 2013. I received proposals from three contractors on June 10, 2013. All of the proposals were deemed responsive and met the requirements.

Johnson Controls Inc., who is our current contractor, has the lowest fixed price and labor rates. The restructuring and changes in the contract, along with the competitive market we have saved the school district a significant amount of money. This is a five year contract. The existing contract, without the addition of the new building at Bowling Green Elementary, is \$1,368,431. Their new proposal is \$255,550 per year or a contract total of \$1,277,750. This represents a savings over the term of the contract of \$90,681, almost 7%, and includes the additional equipment. Continuing with Johnson Controls will also keep personnel familiar with our equipment here eliminating the need for a costly transition period.
