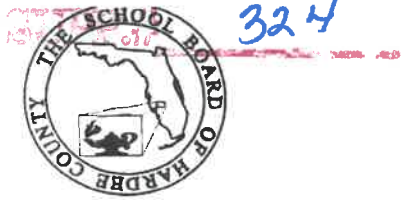

## PROFESSIONAL SERVICES AGREEMENT

This Agreement is made and entered into by and between the School Board of Hardee County, Florida, hereinafter referred to as the "School Board", 1009 North Sixth Avenue, Wauchula, Florida, 338873, and Katie Moye, hereinafter referred to as the "Provider", Post Office Box 1752, Wauchula, Florida 33873.

### PURPOSE

The purpose of this Agreement is to provide Speech/Language services for students of the School Board at designated schools. The services will be given under the established applicable policies of the School Board and within the policies, scope and limitations set forth by the School Board.

### RESPONSIBILITIES


The Provider agrees:

1. To provide the School Board with Speech/Language therapy and evaluations for students at the rate of \$52.00 per hour.
2. To provide the School Board with a copy of current license.
3. To participate in meetings and staffing conferences as needed. Meetings will be scheduled a minimum of one week in advance.
4. To provide the School Board with a semimonthly statement based upon the fees outlined above. Total hours for evaluations, therapy sessions and staffing conferences will not exceed 37.5 hours in a one week period.
5. The Provider agrees to retain all required records for three years after final payments and all other pending matters are closed.
6. Access to any books, documents, papers and records of the provider which are directly pertinent to this agreement for the purpose of making audit examinations, excerpts, and transcriptions will be made available to State and Federal agencies and the Comptroller General of the United States.
7. To maintain the necessary records as required by the School Board.
8. By accepting the terms hereof and entering into this Agreement, Provider agrees that said evaluations and all information gained there from shall remain confidential and property of the Board to be used for educational purposes.

The School Board agrees:


1. To provide space in which evaluations and therapy sessions can be delivered in accordance with the program philosophy.
2. To provide office and storage space for therapists.
3. To supply necessary forms and therapeutic materials for therapist and all supplies and materials will remain property of the School Board.
4. To make records of students available to therapist as needed.
5. To pay the Provider the schedule of fees for professional services as set forth in the Agreement. Payment will be made within 30 days upon receipt of statement.

This Agreement shall be effective on July 1, 2019, and shall continue in effect until June 30, 2020, unless terminated by mutual agreement of the parties or until either party hereto shall cancel it by giving to the other party a thirty (30) day notice. Upon termination of agreement the provider will present an invoice for services rendered through termination. Payment will be made within 30 days upon receipt. Post school year services will be on an as needed basis.


