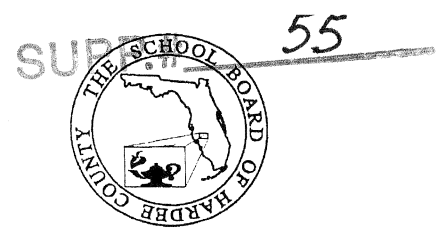


Administrative Consideration: (include F.S., Rule, Authority, etc.):
