

Exempt Employees — 188 day contract

Professional Development Days & Workdays

- **Aug. 1- 3** = New Teacher Orientation
- **Aug. 4** = Required Institute

- One non-student contact Workday at principal's discretion (registration, parent night, etc.). The nurse should meet with principal to determine this date.
