

There are two ways to generate a Benefit Estimate.

1. Contact TRS at 1-800-352-0650 and request a Benefit Estimate be mailed to you. Please allow 30 days for your benefit request to be sent to you.
2. Log into your TRS account and follow the steps below to generate an online Benefit Estimate.
