

Parent/Guardian Terms of Use and Protection Plan Agreement

****Student will not be issued laptop until form is filled out and returned signed.****

I understand that paying **the Annual JCS Protection plan payment of \$30.00** will cover my child's assigned device for the full replacement cost of **accidental/unintentional** damages totaling up to \$250.00. JCS is now offering a multi-child discount. See back for details. Lost chargers will be replaced **only one time** through this protection plan. If I opt out of the protection plan, I understand that I am held liable for any damage to the device which could cost up to \$250.00 as stated in the current JCS policy.

I understand that my child's ability to use and have access to technology is imperative for his/her future success in today's job market; therefore, my child will receive my full support in his/her academic endeavors. I understand that my child's device must be returned to Jefferson County Schools at the end of the school year (or upon his/her withdrawal from JCS) in its protective case. The device should be returned in good condition and in good working order with all accessories issued including the charger.

I understand **intentional and/or malicious damage is not covered** under this plan and students are subject to discipline at the school level.

Accidental damage will be repaired according to the repair rates following and will be deducted from the student's plan balance of \$250.

System Failure	Potential Cause
Motherboard	Faulty electronic component on system board
Memory	Bad memory module
Operating System Errors	Corrupt boot files, Windows Update failure
Hard Drive	Electronic failure in hard drive
Charging Brick	Incorrect voltage output
Power Button	Documented model design failure
Charging Plug In (on laptop)	Documented model design failure
