- If the request is rejected, the notification will include the reason for the denial and steps to appeal the decision.
- If a district does not respond to a request within 45 days of the request, the request is treated as a denial and the parent/guardian can appeal.
- Under the Choice law, the nonresident school district becomes responsible for all matters related to the education of the student (basic education, special education, home/hospital services, truancy, CEDARS reporting, administration of state educational assessments, etc.). ## ACKNOWLEDGEMENTS

- I understand that approval of this request shall be dependent upon the acceptance and rejection standards stated in the nonresident school district's policy, and rescindment (revoking) of this transfer may occur in accordance to the conditions listed in the nonresident school district's policy.
- I understand that my student must continue to attend the resident school until the effective start date of the transfer and that nonattendance is subject to truancy procedures.
- I understand that I will be responsible for providing transportation to and from school for my student, unless the nonresident district is required to provide transportation for the student with a disability under Section 504 of the Rehabilitation Act of 1973 or the Individuals with Disabilities Education Act (IDEA).
- I understand that requests are approved for one school year only, and it is my responsibility to complete a new form each year.
- I understand that should my student move and no longer be a resident of the district, the transfer expires and I must submit a new request to the new resident school district.
- FERPA Release: I authorize the resident school district to release any and all of my student's educational records to the Choice Coordinator of the nonresident school district. By my signature I acknowledge that although I am not required to release my student's records, I am giving my consent to release the information. This release will remain in effect while my student is enrolled unless I revoke such consent in writing. Note: Information will be provided in written format; no information will be released over the phone.  
The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232(g); 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education. FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students." Parents or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies. Generally, schools must have written permission from the parent or eligible student in order to release any information from a student's education record.

## APPLICATION FOR NON RESIDENT ADMISSION

I request the Kittitas School District accept this student as a nonresident student during the above identified school year, only if program space is available.

I realize Kittitas School District reserves the right to make building assignments, and that approval of this request constitutes admission to the school district and not to a specific building. I understand approval of this request shall be dependent upon the availability of space in appropriate grade level or classes, and the student maintaining regular attendance. If this request is approved, I, the parent/guardian, will take full responsibility for transporting this student to and from the school building to which he/she is assigned and for ensuring his/her regular attendance.

If this request is approved, I understand this student will be subject to and will comply fully with the same school and school district rules and regulations as other district students. I further understand that failure to comply may result in withdrawal of permission to attend the Kittitas School District in the current and ensuing years.

If the choice approval is revoked for any reason the non-resident district will notify the resident district. Any further consideration for placement within the non-resident district must be a new and separate application for admission from the resident district.

- In addition to the foregoing, any interdistrict transfer must be in compliance with all other district policies including those relating to student attendance, academic standards and class size.
- Due to public safety concerns, the Kittitas School District reserves the right to deny admission to any student who has previously been expelled or suspended from any school for the possession of a firearm or other dangerous weapon, or for exceptional misconduct.
- The rules of the Washington Interscholastic Activities Association will be followed concerning athletic eligibility of transferring students.
