

PROPOSITION NO. 1: 2017 – 2018 SCHOOL BUDGET

RESOLVED, that the Board of Education of the Lawrence Union Free School District No. 15, Town of Hempstead, Nassau County, New York is authorized to expend the sum of **\$100,783,090** during the 2017-2018 School Year, and is further authorized to levy the necessary tax for the above purpose upon the taxable property of the School District, after first deducting the monies available for state aid and other sources.

RESOLVED, that the sum of **\$2,943,460** be appropriated for library purposes for the Peninsula Public Library, and that said amount be raised by tax upon the taxable property of the Lawrence Union Free School District No. 15, pursuant to § 259 of the Education Law, and be levied and collected in the same manner as are general taxes, after first deducting the monies available from state aid and other sources.



