Superintendent's Comments

Tax Levy

The tax levy for 2023, which will be applied in 2024 on property taxes, is a rate of 3.79. This is a decrease from the past few years. However, tax payers will see an increase due to the value of their land having increased in the equalized assessed value of about 8.6%.

Policy updates

PRESS policy had the first reading. A new policy on unpaid school fees had a second reading and has been adopted. It will be in effect for the 2024-25 school year. See attached. In addition, a first reading occurred on new policies regarding mid-term graduates and AP courses counting towards the GPA.

Superintendent's Evaluation

By law, the school board is supposed to conduct an evaluation each year of the superintendent. This occurs in December and is approved in January.

Dance Team

Since a high school dance team is being piloted this school year, a student activity account needed to be set up for the financial transactions associated with it.

MOU

Transitions of Western Illinois has applied to be a comprehensive community behavioral health clinic. If this is approved, they will be providing services to Liberty School District.

IASB update

Under the reports section, we have added another report from our Illinois Association of School Boards (IASB) rep, Laura Meyer, to give the entire board updates on what the school board association is doing.

Postal Agreement

Due to new postage rules and regulations, we had to update our postal machine. This required us to enter into a new agreement for 24 months.

Delayed Payment

The school board approved a purchase of a gas bus, but it will not pay for it until July 2024, to keep with the plan of purchasing one vehicle per year.
