Superintendent's Comments

District Finances

The audit for the district was presented and approved. A 3-year expenditure report was presented, as required by law. This led into talking about the tax levy. The school board is keeping the same tax rate as it has been for a few years. The reason is that property value is going up about 8.6% in the Liberty District, so the school board did not want to add to this increase. In comparison to other districts in this area, which was provided at the board meeting, Liberty has one of the lower tax rates. Thus, tax payers will see an increase in their property taxes due to the increase in the equalized assessed value of their property, not because the school board raised their tax levy rate.

Resolutions

One resolution was approved for the estimated Tax Levy for 2023. Another resolution was to support the application for a new sidewalk funded by Safe Routes to School. If the application is approved, the village of Liberty will put in a new sidewalk from the school parking lot that wraps around the block to Highway 104.

School Report Card

The 2022-23 District Report Card was approved. This year JH/HS received a summative designation rating of being Exemplary and Elementary received the rating of Commendable. Schools fall within one of four performance **designations**: Exemplary, Commendable, Targeted Needs, and Comprehensive Needs. Discussions are being had by the staff on how to continue to grow and be better for years to come. This involves looking at the data constantly on both proficiency and student growth. Tennille Gimm, RTI Coordinator, was at the board meeting to go over fall benchmark data at the various grade levels.

Policy for Unpaid Fees

There was a first reading on a policy regarding unpaid school fees. By Oct. 15 of each year, families need to pay their fees in full, set up a payment plan, or contact school with a plan on how to work off the fees. After October 15, all parties with outstanding fees will be turned over to the collection agency. At that point any payments must be made to the collection agency.

Purchasing a trailer

A trailer to use for band and athletics was approved to be purchased from New Line Trailer located in Troy, MO. This will help our extra-curricular groups with their equipment.

Discussion item

The school board discussed putting 3m film on windows and doors of the school building to increase security. This will be paid out of the Tort Fund. This item is still being looked at.
