NOTICE OF PROPOSED TAX INCREASE

The Liberty County School District will soon consider a measure to increase its property tax levy.

Last year's property tax levy:

A. Initially proposed tax levy.....\$1,350,026

B. Less tax reductions due to Value Adjustment Board and other assessment changes.....(\$4,029)

C. Actual property tax levy.....\$1,354,055

This year's proposed tax levy...\$1,710,278

A portion of the tax levy is required under state law in order for the school board to receive \$10,093,264 in state education grants.

The required portion has decrease by -.99 percent, and represents approximately seven tenths of the total proposed taxes.

The remainder of the taxes is proposed solely at the discretion of the school board.

All concerned citizens are invited to a public hearing on the tax increase to be held on July 28, 2014 at 5:05 P.M., E.S.T., at the Administrative Center, 12926 NW CR 12, Bristol, FL 32321.

A DECISION on the proposed tax increase and the budget will be made at this hearing.

NOTICE OF TAX FOR SCHOOL CAPITAL OUTLAY

The Liberty County School District will soon consider a measure to impose a 1.5 mill property tax for the capital outlay projects listed herein.

This tax is in addition to the school board's proposed tax of 5.827 mills for operating expenses and is proposed solely at the discretion of the school board.

The capital outlay tax will generate approximately \$350,132.00 to be used for the following projects:
