Minutes – Executive Session

Mr. Smith shared the letter of resignation / retirement from Onnie Hessefort, Bus Driver. A motion was made by Ebeling, seconded by Eichler to accept the resignation / retirement letter as presented. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-yes; Parrott-yes; Rutherford – yes; Beaman-absent; and Mehrens-yes. Motion carried 6 yes, 0 no.

Mr. Smith recommended David Crouch for the open Bus Driver position. A motion was made by Ebeling, seconded by Parrott to employ David Crouch, as Bus Driver for the 2019-2020 school year. A motion was made by Parrott, seconded by Rutherford to employ Travis Goosen for JH Assistant Boys Basketball for the 2019-2020 school year. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-yes; Parrott-yes; Rutherford-yes; Beaman-absent; and Mehrens-yes. Motion carried 6 yes, 0 no.

Mr. Smith shared the letter of resignation from Shelby Williams, fourth grade Elementary. A motion was made by Parrott, seconded by Ebeling to accept the resignation as presented. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-yes; Parrott-yes; Rutherford – yes; Beaman-absent; and Mehrens-yes. Motion carried 6 yes, 0 no.

Mrs. Eifert recommended hiring Heather Kessing as 4th grade Elementary teacher. A motion was made by Yearout, seconded by Eichler to employ Heather Kessing as the Elementary teacher for the 2019-2020 school year. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-yes; Parrott-yes; Rutherford-yes; Beaman-absent; and Mehrens-yes. Motion carried 6 yes, 0 no.

Mr. Smith asked to bring the Spring extra duty recommendations to the next board meeting so that the Administrators can meet and discuss this year's events.
