Minutes – Executive Session

May 15, 2017

The Benton County R-2 School District board members continued the meeting in executive session on May 15, 2017 beginning at 7:38 P.M. Board members present were Mehrens, Kroenke, Beaman, Parrott, Eichler, and Yearout. Ebeling was absent

Kevin Smith, Marc Spunaugle, Becky Eifert, Michelle Smith, and Carol Waibel were also present.

Mr. Smith shared information on the candidates who had been offered the Elementary Physical Education position and the High School Business position for 2017-2018.

A motion was made by Yearout, seconded by Eichler to employ Laurel Larimore as the Elementary Physical Education teacher for the 2017-2018 school year. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-absent; Parrott-yes; Beaman-yes; Kroenke-yes; and Mehrens-yes. Motion carried 6 yes, 0 no.

A motion was made by Beaman, seconded by Kroenke, to employ Scott Calhoun as the High School Business Teacher for the 2017-2018 school year. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-absent; Parrott-yes; Beaman-yes; Kroenke-yes; and Mehrens-yes. Motion carried 6 yes, 0 no.

Mr. Smith shared that Travis Goosen had declined the Junior High Boys Basketball coaching position for 2017-2018 due to other commitments during the summer which would not allow him to get the boys in summer camps.

Mr. Smith recommended that the board offer employment for the following positions for 2017-2018-- Will Lynde as the Junior High Boys Basketball coach, Lane Johnson as Assistant Junior High Boys Basketball coach, Scott Calhoun as Junior High Volleyball and FBLA Sponsor, Chris Sanders as Softball, Laurel Larimore as Varsity Volleyball and Assistant Softball, Kevin LaFavor and Johnny Eierman for the Summer Weight Program, Margaret Cook as High School Basketball Cheerleading Coach and JH Football Cheerleading Coach, and Sandy Terrell as A+ Coordinator. A motion was made by Beaman, seconded by Yearout, to employ the positions as recommended. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-absent; Parrott-yes; Beaman-yes; Kroenke-yes; and Mehrens-yes. Motion carried 6 yes, 0 no.

There being no further business for executive session a motion was made by Yearout, seconded by Parrott to adjourn the executive session at 8:02 P.M. Roll call vote of motion carried as follows: Yearout-yes; Eichler-yes; Ebeling-yes; Parrott-yes; Beaman-yes; Kroenke-yes; and Mehrens-yes. Motion carried 6 yes, 0 no.
