At 5:33 p.m. Dr. White made the motion to enter into Executive Session in accordance with WV Code 6-9A-4 for the purpose of Student expulsion. Mrs. Mendez seconded the motion. Motion carried. Vote was 4-0 unanimous. Mr. Frye was not in attendance.
