A regular meeting of the Logan County Board of Education was held at the Ralph R. Willis Career/Technical Center on Thursday, June 9, 2016 at 6:00 p.m.

Call to order

The meeting was called to order by Board President Dr. Pat White. Those present were, Phyllis Adkins, Don Elkins, Debbie Mendez, Chad Preston, Phyllis Doty-Secretary, and Shana Thompson-General Counsel for the Board.

Pledge of Allegiance

The Pledge of Allegiance was led by Teresa Justice.

Moment of Silence

A moment of silence was observed.

Public Speakers, Presentations and Recognitions

Teresa Justice requested to speak to the Board in Executive Session.

Paul Hardesty, Board Member Elect for Logan County Schools, addressed the Board concerning the Geo Tech survey on the Holden Project. Speaking on my own behalf, my initiative is to talk to the new Board in July to seek legal recourse on Geo Tech work being done at Holden. I think we will need to explore their errors of mission insurance. I want to state that for the record. They were told before we started there was a mine in that area. This Board was given notice to precede in December, once they preceded we begin to hit problem after problem with respect to the Geo Tech portion of this. We cannot and will not waste taxpayer dollars in Logan County pumping concrete in a hole because someone did not do their due diligence. Our kids at Holden deserve these classrooms and gym. I hope this Board in July will seek legal recourse to get some help with the Geo Tech side of this project.

Can someone tell me on the transfer section on the personnel schedule why are there blanks? There should no blanks, that is what addendums are for. Not fair to a Board of Education that you hand them something with blanks with no discussion, they don't know who applied for jobs. Should have been done in advance. This is unacceptable.

Some of you this comment does not apply to, some of you if it hurts I am sorry from the bottom of my heart. You all have forgotten who and by what charge why you have taken theses seats. Citizens, taxpayers and children of Logan County are who were supposed to serve. Not self-serving interests. Change is on the way come July 1.

Greg Williamson explained why additional caisson had to be drilled due to the discovery of mine shafts and foundations issues at the Holden Elementary project. The additional caisson would support grade beams to support a structural slab. A structural slab is self-supporting, it doesn't sit on the ground. In the event, if there was ever a structural failure of the shaft, the building would stand despite of what would happen underneath it. This requires an additional 12 caisson in that part of the building, due to the discovery of a second shaft.

Tim Malcomb, MIRC, explained the additional foundation work required and presented the Board with several different cost estimates and options due to the discovery of mine shafts at the Holden Elementary project.

MIRC is still working on classrooms but will need a decision on the gym soon. The classrooms are not in the voided area. No structural issues at all with the classroom part.

The Board was informed that all materials has either been purchased or produced for the construction of the gymnasium.
