RESOLUTION

WHEREAS, West Virginia's entire Public Education system continues to be underfunded leading to shortages of teachers, service personnel, nurses, psychologists, counselors, and special education staff; and

WHEREAS, Public schools are at the heart of community well-being; and **WHEREAS,** County Boards of Education budgets are already severely strained; and

WHEREAS, the West Virginia Legislature has a duty to provide a thorough and efficient system of free education in the State and the Logan County Board of Education has been delegated such duty for Logan County, West Virginia; and WHEREAS, the Senate Education Committee has originated SB 451, the Omnibus Education Bill, which proposes certain reforms to public education with little, if any, meaningful collaboration with education stakeholders in West Virginia; and

WHEREAS, the proposed Omnibus Education Bill ties school employee pay raises promised by the Governor of West Virginia with education reform; and

WHEREAS, Certain provisions of the proposed Omnibus Education Bill are detrimental to public schools and the ability of the Logan County Board of Education to provide a thorough and efficient system for all students in Logan County; and

THEREFORE, BE IT RESOLVED THAT, the Logan County Board of Education opposes any and all efforts to use public funds which make any changes that do not lead to higher student achievement; and

BE IT FURTHER RESOLVED THAT, the Logan County Board of Education urges the West Virginia Legislature to pass the Governor's pay raise and engage the West Virginia's education stakeholders in developing meaningful education reforms necessary to improve educational outcomes for all children served by West Virginia's public schools.
