

BID FOR WMS GYMNASIUM PAINTING 2019

I. SCOPE OF WORK:

Manchester City Schools is seeking competitive bids for materials and labor for the painting of the Westwood Middle School gymnasium and surrounding areas. The successful bidder will paint ceiling, beams, walls, and basketball supports. The contractor selected must supply all labor, transportation, apparatus, materials, and tools necessary for the completion of the work, maintain and remove temporary equipment, and complete painting in excellent and workmanlike fashion. Contractor must be qualified for this work. Contractor selected will be responsible for any damages to the site. The work is to be completed by July 19, 2019.

II. BIDDER IS RESPONSIBLE FOR:

- conditions of work at site
- providing documentation of appropriate insurance / bonding
- verification of all state / federal mandates including prevailing wage

All flooring, glass, bleachers, cameras, speakers, technology etc. shall be covered at all times. All over-spray, etc. must be removed after painting.

III. SPECIFICATIONS:

Cleaning – All surfaces must be appropriately cleaned prior to painting in accordance with paint manufacturer's recommendation.

Preparation – All surfaces must be appropriately prepared prior to painting in accordance with paint manufacturer's recommendation

Materials - Ceiling tectum board, joist, and all other components shall be painted complete with Premium Farrell Calhoun FC # 999 Dry – Flat white or equal product will be considered for approval .

Blocking out the existing graphics and verbiage on the walls above wainscot prior to painting will be required. Premium Farrell Calhoun FC # 599 Alkyd Undercoat or equal product ,shall be applied a minimum of 24 hours before the finish material is applied. Primer shall also be used on stains and fillers.

The finish for the walls both upper and the wainscot shall be Premium Farrell Calhoun # 800 series or equal product .The colors shall be white ceiling down to bottom of windows ,gray walls with a navy accent strip ,and carolina blue strip below navy blue .All trim around stage shall be white .

IV. PAYMENT FOR SERVICES

Payment shall be made within 30 days of satisfactory completion of the project. A bill must be submitted to the district office identifying the contractor name and address, phone number, performed date of work, the authorized project cost , and purchase order number.

V. BUILDING AND LABOR CODES

Contractors are expected to meet and/or comply with all building, health life safety codes and labor regulations applicable to school buildings/districts in the State of Tennessee.

VI. RESERVATION OF RIGHTS OF THE DISTRICT AND ASSESSMENTS

- A. The Board of Education reserves the right to reject any and all proposals, to reject any part of parts thereof, to waive irregularities or technicalities in the RFP process, and to accept that proposal which is considered by the Board of Education to be in the best interest of the District.
- B. The Board of Education reserves the right to award each item to a different contractor or all items to a single contractor unless otherwise noted on the bid submitted.
- C. The Board of Education reserves the right to determine whether in the opinion of the Board of Education: (1) an equal or alternate is a satisfactory substitution; (2) a contractor is not a responsible contractor and should warrant less consideration; and, (3) what exceptions or deviations from written specifications will be accepted.
- D. The Board of Education will not obligate itself to accept the lowest or any other proposal. It will consider, in addition to price: (1) the quality and availability of competent service on items which may require service; (2) service which represents, in the opinion of the Board of Education, the best value per dollar of cost.
- E. The decision of the Board of Education shall be considered final.
- F. All proposals submitted shall be valid for a period of sixty (60) days from the date of the proposal opening, after which all contractors will be informed regarding the Board's decision.

G. A mandatory pre-bid walkthrough will be May 24, 2019, 1:00 pm (cst)
