# Reports of Committees

<u>Building Committee</u> – Chairman Gary Preston reported the committee met on Tuesday regarding the Elementary School progress. Adam Verducci, Gilbane Project manager, reported the following:

- Interior masonry walls
  - Early Childhood 100% complete
  - Administration 100% complete
  - Multipurpose 70% complete
  - Kindergarten 85% complete
- Roofing nail base, insulation and vapor barrier nearly complete in all areas. The metal fascia and gutter installation has started. Ductwork, gas piping, fire sprinkler piping, and overhead plumbing are underway.
- The metal panels have been traced and should be here in two to three weeks.
- Metal framing
  - o Top of wall, ceiling, and soffit framing is nearly complete in Early Childhood area.
  - o Started wall framing in the Administration section.
  - o Started top of wall framing in the Kindergarten section.
- Installation of temporary window and door openings protection is complete.
- Temporary heat to begin next week.
- Windows are expected to be delivered the last week in November.
- The new parking lot stabilization and base has been installed.
- Pavement pending with weather.
- Cost update total cost balance is \$8,950,702 to finish including retainage. The building is 45.5% complete with expenditures of \$4,873,840.79

Member Murray arrived at 6:50 p.m.

<u>Finance Committee</u> – Chairman Mallaney reported the committee met tonight to discuss the tax levy. It was recommended to approve the public hearing date and adopt at the December meeting. Also discussed were contract agreements and Scholastic Reading. It was agreed to approve the renewals presented. The committee also approved the allowance to upgrade the grease trap, spoke about the Health Care Affordability Act, reviewed the revenue update, as well as the finance packet.

<u>Curriculum, Instruction, and Assessment Committee</u> – The committee did not meet because of scheduling conflicts.

<u>Technology Committee</u> – Tom Steele reported the committee met early this month and will not meet in December. This was a big meeting regarding the one to one deployment. There will be parent, staff and student meetings regarding the deployment of one to one computing in 5<sup>th</sup> grade. There were just a few tech glitches, but well accepted, the students should be able to take them home soon. If funds were available, the committee would like to see devices go to sixth grade next year, as well as deploy in the 4<sup>th</sup> grade. If the State pays the money that is owed the District, it would make it a financial possibility. Google came out with new Google Chrome book pricing. This would be a golden opportunity at \$229 each.

- The High School PRIDE Program received a \$2,000 grant from the Exxon Mobil Corporation Matching Gift Program. The grant money will go towards equipment, T-shirts and track uniform purchases for all athletes.
- There were staff members in the news for Project ACES (All Children Exercising Simultaneously). Elementary School PE Teacher, Sue Liss and Kristi Rice were photographed walking with students featured in the Illinois Journal for Health, Physical Education, Recreation, and Dance.
