Curriculum, Instruction, and Assessment Committee – Curriculum Director, Cathy Creek, reported she attended the NCLB Conference in Chicago on Monday February 22nd and Tuesday February 23 along with Elementary Teachers and additional Curriculum Department members and all experienced a great conference with a lot of good information. The conference is a great opportunity that is put on by the State. Ms. Creek also reported on the Northwestern University AWE (Accelerated Weekend Experience) Course that the District is hosting at the High School on Saturday February 27, 2016. Selected 5th thru 8th grade gifted students will participate in an ALICE course that allows them to create virtual worlds and interactive games with 3-D programming. They will also participate in a Biotechnology course that will cover a variety of topics. Ms. Creek reported that due to the State budget and their uncertainty on their timeline to offer a college entrance exam (ACT or SAT) to High School students, the District would not be offering the ACT test to the junior class this year. The District will reimburse junior students who take the test elsewhere as they feel it is important for the students to have that test experience.

Technology Committee – Technology Director, Tom Steele reported that the Tech Department met on February 10, 2016 and discussed the Title 1 chromebook price that came in substantially less than anticipated (\$241/device with 4 year accidental damage warranty). All chromebooks will be purchased through Title 1, 93 total. Our e-rate discount has been reduced from 60% to 50% due to our calculation of the free/reduced lunch count based on the January 2016 report (29%). The committee is continuing to work on our E-rate applications and will expect to have Board recommendations at the March meeting. The LearnPad manufacturer has gone bankrupt and Educational Resources is severing all ties with LearnPad as well. Support will now be out of the UK. Our Technology Interns have an opportunity to attend a Student Technology Leadership Summit at Maine East HS on April 22nd. Recommendations for the 2016-2017 Tech Interns will be at the April 2016 Board meeting. Area 3 Learning Technology Center will be discontinuing the Spam Titan Email Spam Filtering service effective June 30, 2016. Replacement solutions are being discussed. The committee is also looking to replace the anti-malware contract as the Vipre contract expires in June, 2016.
