Review monthly financial report for March 2018

Mr. Rausch presented the Monthly Financial Report for March 2018. For the month of March M & O fund has a budget of \$41,661,710 and current expenditures of \$3,118,009. Currently M & O encumbrances are \$12,902,694. Projected fund balance of \$1,047,672 before all entered Encumbrances, Journal Entries for all of our transfers to other Funds and Final Grant Transfers, 85% of our budgets are salary related. District Additional Assistance Fund 610 (formerly Unrestricted Capital Fund and 625 Soft Capital Funds), our budget is \$2,432,063 with \$55,858 spent and a Projected Fund Balance of \$494,371. The class site funds have a budget of \$2,963,374. The Student Activities Report shows a beginning monthly balance of \$149,661.
