OPENING

Call to Order

President Coutré called a meeting of the Maricopa Unified School District No. 20 Governing Board to order at 6:32 p.m. in the Board Room at the District Office Administration Building.

Councilman Henry Wade led the Pledge of Allegiance.

Adoption of Agenda

Mrs. Anderson motioned to approve the agenda. Dr. Miller seconded. Motion passed 4/0.

Call to the Public

Ms. Julia Gusse addressed the board regarding Veterans Reach to Teach Initiative and requested that the administration and Board have this initiative in the back of their minds when hiring new teachers for the District. Dr. Miller announced that on May 4th he will be acting as Police Chief for the day. Dr. Miller visited with Maricopa High School and in the upcoming days he will be visiting Butterfield Elementary School. President Coutré participated with the Butterfield Elementary School 5th grade AWIM project and also attended the field trip at the Nissan facilities. Information Items/Work Study

Santa Cruz Elementary School Academic Focus Update

Principal Dr. Loraine Conley introduced Mrs. Dawn Dodd, 1st grade teacher, who explained Santa Cruz's academic focus being a learning community where staff and students work together to set personal goals. Students set academic goals based on individual data and set healthy nutrition and physical education goals. Mrs. Traci Ragatz, 3rd grade teacher, explained Santa Cruz accomplished more PE & Health classes, NFL Play 60, after school sports, mile meet, and more activities. Mrs. Ragatz further explained specifically for this year Santa Cruz students visited the Halle Heart Museum and during AZ Merit testing, the students continued to participate in PE classes to help ease the stresses of the test taking. Principal Dr. Conley says Santa Cruz plans to continue with teacher goals set within PLC's, student individualize learning plans and posting weekly and quarterly academic class goals. Principal Dr. Conley reported Santa Cruz needs to overcome obstacles that include writing for the 21st Century Grant and a soccer grant; needing a technology teacher; adding blended learning opportunities school-wide; and grade level planning time.

Dr. Chestnut clarified that the items in the FY16 column are one year items and will be funded if Prop 123 is passed in May. To continue funding these three items in FY17 and beyond would be if the override passes in November. The items in FY17 are Prop 123 funding that would continue over the next ten years because it is a ten year revenue stream. Dr. Chestnut explained the district will still have the annual budget process each year and the list will need to be fine-tuned as with all of the items in the budget.

Mrs. Anderson is happy to see that if Prop 123 is passed, those funds are slated to be used in the classroom as that is what is was originally intended for.

2017 Arizona School Board Association (ASBA) Legislative Priorities

President Coutré explained that ASBA has requested that the school boards review the 2017 ASBA Legislative Priorities and pick the top 5 priorities from the agenda and any additional items to be considered and submit to ASBA by May 20th. Each board member provided their top 5 items along with any additional items to consider and the Board Secretary will consolidate those items and send to each of the board members so they can review and vote on what top 5 items will be submitted to ASBA.
