Superintendents Report

Dr. Lopeman reported a successful smooth start to the new school year and credits all of the staff. Dr. Lopeman said school-level training on emergency response and safety; teacher orientation and training; candidate forum; and leadership development has taken place. Dr. Lopeman also said the back to school celebration on August 20th. Dr. Lopeman stated the strategic plan launch will take place on August 29th. Dr. Lopeman presented her thirty-day report which included results of her talks with Governing Board members, district leaders, principals and community members where she inquired and learned about the MUSD culture, history, challenges and what matters most. In the coming weeks, Dr. Lopeman will be speaking with teachers, classified staff, students and parents regarding those same topics. Dr. Lopeman will be launching the Superintendent's Advisory Council in the near future.

Review monthly financial report for June 2018

Mr. Rausch presented the Monthly Financial Report for June 2018. For the month of June M & O fund has a budget of \$42,797,621 and current expenditures of \$5,647.887. Currently M & O encumbrances are \$454,672. Projected fund balance of \$1,471,259 before all entered Encumbrances, Journal Entries for all of our transfers to other Funds and Final Grant Transfers, 85% of our budgets are salary related. District Additional Assistance Fund 610 (formerly Unrestricted Capital Fund and 625 Soft Capital Funds), our budget is \$3,215,482 with \$113,636 spent and a Projected Fund Balance of \$1,207,015. The class site funds have a budget of \$2,963,374. The Student Activities Report shows a beginning monthly balance of \$150,684.86, receipts of \$5,406.75, disbursements of \$21,255.68, and an ending monthly balance of \$134,635.93.
