Call to Order

Mr. Judd led the Pledge of Allegiance.

Adoption of Agenda

Mrs. Anderson motioned to approve the agenda. Mr. Judd seconded. Motion passed 5/0.

Call to the Public

Mrs. Kristina Begonja, kindergarten teacher at Butterfield Elementary School addressed the Board regarding the moving of a kindergarten teacher from Butterfield Elementary School to Saddleback Elementary School as a result of low enrollment at the kindergarten grade level at Butterfield and high enrollment in the kindergarten grade level at Saddleback. Mrs. Begonja proposes the Board look into keeping all kindergarten class sizes small and even and to consider hiring another teacher for Saddleback and to keep the kindergarten teacher at Butterfield to ensure Butterfield's kindergarten class sizes do not increase.

Superintendent's Report

Dr. Chestnut reported as of August 18th, MUSD's total enrollment is 6,660 which is 112 students below what was projected. Dr. Chestnut said typically enrollment continues to grow during the fall and then starts to drop off and Dr. Chestnut anticipates that is what will happen this year.

Dr. Chestnut said on August 18th, the Varsity Rams Football team won their first regular game of the season 45-13. Dr. Chestnut reminded everyone that on August 24th the high school will be featured on Sonoran Living between 9-10 a.m. On August 31st Dr. Chestnut will be attending the Maricopa Education Association quarterly meeting.

Dr. Chestnut announced Maricopa High School Homecoming Week will be September 11-15th. Dr. Chestnut said the preliminary plans for homecoming week consist of Ramfest at CopperSky on September 14th and homecoming parade on September 15th.

Dr. Chestnut reported that the RAM Academy progress is moving along, the skirting is being installed around the trailers and trenches are being dug for the utilities. Dr. Chestnut said the plan is to have students moved into these classrooms in a couple of weeks. Dr. Chestnut said there are currently 98 students attending RAM Academy.

Dr. Chestnut said the district is having discussions with F.O.R. Maricopa food bank on the possibility of allowing the food bank locate temporarily into two classrooms at Santa Cruz Elementary until their permanent facility is built. Dr. Chestnut explained a final decision has not been made on this, but if this is something the district allows, some electrical work will need to be done that F.O.R. Maricopa will have to pay for according to the Facilities Usage policy. Dr. Chestnut stressed this will not interfere with Santa Cruz Elementary school's operations. Mrs. Anderson requested more information as she is not comfortable about this.

Governing Board Member Activity Reports

Mrs. Anderson will be attending the Arizona School Board Association (ASBA) Law Conference on September 7-8th and will be conducting the ASBA Delegate Assembly on September 9th.

President Coutré attended the Councilman on the Corner with Councilman Wade regarding the possibility of multi-family dwellings. President Coutré attended the MHS varsity football game and announced the next home game will be on September 8th. President Coutré expressed kudos to Mr. Chad Whittle and staff for the banner of seniors that was on display at Ram Stadium. President Coutré thanked everyone who has been sending e-mails to the Board regarding any issues they've been having.

Dr. Miller and Mr. Judd thanked The Dugan Family for their generous donation of shade covers over the Maricopa Wells Middle School baseball dugouts.

Dr. Miller participated in the ASBA Webinar.
