### **Information Items/Work Study**

## Recognition of Future City Competition Participants

2017 Future Cities Arizona State 2<sup>nd</sup> Place Team Sura (Maricopa Wells Middle School) and 3<sup>rd</sup> Place Team Jakarta (Desert Wind Middle School) performed their presentations of their future cities. Maricopa Wells Middle School 20+1 Teacher Mr. Szoltysik explained the details of the Annual Future Cities Competition. Dr. Chestnut presented all the Arizona State Future City Competition participants with recognition certificates.

## Maricopa High School Presentation

Principal Renita Myers introduced Mrs. Aiden Balt, Mr. Joby Thompson and Mrs. Michelle Schafer. Mrs. Balt spoke about the Advanced Placement (AP), Honors and Gifted Programs at the high school. Mrs. Balt

explained the high school has 12 honors classes, 13 AP classes and 19 of the high school teachers have been trained in AP teaching strategies. Mrs. Bolt said MHS was recognized on the 7<sup>th</sup> Annual AP Honor Roll for advancements and achievements during the 2015-16 school year. Mrs. Balt is the high schools Gifted Liaison that has been added this year and states the high school currently has 50 students identified as gifted. Mrs. Balt said they are working on professional development for the teachers and the philosophy is that our gifted students should have their unique learning needs met in any course.

Mr. Thompson explained that CTE is Career and Technical Education that incorporates industry specific skills into the high school classroom so students can follow career paths and job lines as they go through their high school career. Mrs. Schafer said five of the CTE programs have certifications associated with them. Mr. Thompson spoke about the CTSO (Career and Technical Student Organization), CTE teacher's professional development, and CTE teacher accolades. Mrs. Schafer spoke about the CAVIT program.

Principal Myers described that improvements that the high school is working on is continued CogAT testing; continued growth of Honors and AP classes with focus on access for all students to rigorous college level coursework; continued teacher training (AP and Pre-AP); continued recruitment of CTE program "completers"; and cross-curricular and embedded math/ELA standards.

## Review Monthly Financial Reports for December 2016

Mr. Rausch presented the Monthly Financial Report for December 2016. For the month of December M & O fund has a budget of \$36,689,542 and current expenditures of \$3,771,444. Actual M & O expenditures for the year are \$16,652,713 and current encumbrances are \$19,567,609. Projected fund balance of \$469,220 before all of our transfers to other Funds and Final Grant Transfers, 85% of our budgets are salary related. Additional Assistance Fund 610 (formerly Unrestricted Capital Fund and 625 Soft Capital Funds), our budget is \$3,963,596 with \$206,857 spent and \$123,421 encumbered for the year with a Projected Fund Balance of \$3,121,648. The class site funds have a budget of \$3,021,646. The Student Activities Report shows a beginning monthly balance of \$146,264.52, receipts of \$24,152.14, disbursements of \$25,110.47, and an ending monthly balance of \$141,716.01.
