# Maricopa Elementary School Presentation

Principal Dr. Jen Robinson explained that Maricopa Elementary School (MES) is a Leader in Me school which means they focus on the seven habits of highly effective people. Dr. Robinson says MES is a National Board of Professional Development school and currently have 13 teachers working towards their National Board Certification. Dr. Robinson states this year Maricopa Elementary School has piloted Scholar Led Leadership Clubs in several classrooms and at the school-wide level. Numerous students presented and explained their leadership clubs. Dr. Robinson says their next steps is to expand the leadership clubs to all classrooms, and increasing the school-wide clubs as they continue to partner with the community and stakeholders. Dr. Robinson states they will continue to embrace the seven habits and move towards the highly effective paradigms of developing the whole child. Dr. Robinson says their goal next year is to reach Lighthouse status with Leader in Me.

## Review Monthly Financial Reports for January 2017

Mr. Rausch presented the Monthly Financial Report for January 2017. For the month of January M & O fund has a budget of \$36,689,542 and current expenditures of \$2,656,605. Actual M & O expenditures for the year are \$19,309,318 and current encumbrances are \$17,302,060. Projected fund balance of \$78,165 before all of our transfers to other Funds and Final Grant Transfers, 85% of our budgets are salary related. Additional Assistance Fund 610 (formerly Unrestricted Capital Fund and 625 Soft Capital Funds), our budget is \$3,963,596 with \$30,031 spent and \$310,581 encumbered for the year with a Projected Fund Balance of \$2,904,456. The class site funds have a budget of \$3,021,646. The Student Activities Report shows a beginning monthly balance of \$141,716.01, receipts of \$8,539.62, disbursements of \$12,018.78, and an ending monthly balance of \$137,787.40.
