Meeting of the Governing Board September 27, 2017

OPENING

Call to Order

President Coutré called a meeting of the Maricopa Unified School District No. 20 Governing Board to order at 6:30 p.m. in the Board Room at the District Office Administration Building.

Pledge of Allegiance

Councilman Henry Wade led the Pledge of Allegiance.

Adoption of Agenda

Mrs. Anderson requested to move item 6F from Consent Agenda to Action Items. Dr. Miller requested to move item 6D from Consent Agenda to Action Items.

Dr. Miller motioned to approve the agenda as amended. Mr. Judd seconded. Motion passed 5/0.

Call to the Public

No one addressed the Board.

Superintendent's Report

Dr. Chestnut reported that on September 15th the Annual Kids Day Maricopa was held at Maricopa Wells Middle School. On September 20th Dr. Chestnut had a meeting with the Phoenix Boys Choir Sr. Director and Director of Education and discussed the possibility of a neighborhood choir for elementary school aged boys in Maricopa.

Dr. Chestnut said on September 26th the first Certified Advisory Committee Meeting was held and there are approximately 21 people on the committee, which consists of 2 people from each school except for the high school who has 4 people participating.

Dr. Chestnut announced on October 1st the MUSD newsletter will be mailed out to 20,000 Maricopa households in the inMaricopa magazine.

Dr. Chestnut said the progress on the Ram Academy building is delayed due to the city code requiring the building to have two ramps (not one as was originally designed). Dr. Chestnut says two metal ramps are currently being fabricated and this is the last hurdle to overcome in order for the Ram Academy students to be able to utilize the building.

Governing Board Member Activity Reports

Mr. Judd announced that Governing Ducey's plan for Teacher Academy has officially gone live as of today. Mr. Judd explained this Teacher Academy offers 200 scholarship or full ride grants to ASU, NAU, or U of A for anyone who is interested in becoming a teacher in Arizona school districts.

Dr. Miller participated in a ride along on a Desert Wind Middle School bus route.

Mrs. Anderson attended the homecoming activities which included the homecoming football game and RamFest. Mrs. Anderson also attended the Kids Day at Maricopa Wells Middle School.

Mrs. Anderson announced that October is Domestic Violence Awareness Month and there are several activities going on that include on Oct. 2nd the Pinal County Attorney's office will be doing a domestic violence proclamation in Florence, and on October 3rd the City of Maricopa will be doing a domestic violence proclamation. Mrs. Anderson also reminded everyone that on October 4th the State of the City Address will take place, October 10th is the ASBA Legislative Workshop, October 15th is the Annual Taste of Casa Grande, and on Oct. 17th Mrs. Anderson will be presenting at City Council Meeting.

President Coutré attended the homecoming activities. On September 14th President Coutré attended the Desert Wind Middle School Take Your Legislature to School Day and the Maricopa Booster golf outing on Sept. 23rd. President Coutré thanked the Transportation department for utilizing ConnectEd for providing bus route information out to parents. President Coutré mentioned that at the ASBA Pinal County Workshop, she and Mrs. Anderson are being awarded the Copper Awards.

Discipline Policy Discussion

Mrs. Anderson questioned why the code of conduct violations and consequences in the elementary and secondary handbooks are in different formats although they basically say the same thing. Mrs. Anderson feels the secondary code of conduct violations and consequences format is clearer and the elementary is harder to follow and interpret. Dr. Chestnut answered that approximately five years ago the district's Attorney recommended to make the format change for elementary as the grid at that time was not developmentally appropriate and did not give enough range of options for the principals. Dr. Chestnut says the code of conduct violations and consequences is to give principals the ability to have a uniform set of consequences where the rules are the same for everyone but they are applied individually because no two students are the same and no two situations are the same. Mrs. Anderson would like the format of the elementary code of conduct violations and consequences to be looked at again to be made into possibly a grid like the secondary one to make it easier to follow.

Mrs. Anderson suggests under the drug and intimidation offenses when it is the students first offense to do a diversion or a restorative of practices behavior program. Mrs. Anderson would also like the truancy to be looked at with the truancy officers to make sure it is working. Mrs. Anderson would also like to see a class or clarification with principals and teachers on what mutual participation is and how to define it. Mrs.
