Farm Bureau Scholarship: Scholarships amount vary yearly. Must be a member of Brown Country Farm Bureau family.	March	
Mid-Tex Scholarship: Scholarships amount vary yearly. Must be a member of Mid-Tex Federal Credit Union.	May	
Pecan Valley Kiwanis Club: 4- \$1,000scholarships are available to seniors for higher education (Vo-Tech, College).	April	
TSTC Scholarship: The first one is for students who are planning to attend the new TSTC-Abilene ITC campus under the structural welding, industrial maintenance, or electrical power and controls programs. There is no essay or pre-requisite for this scholarship. Just that you will be attending the new Abilene campus under one of the three mentioned programs. The scholarship is for \$1,000. The second scholarship is available for anyone wanting to go to any TSTC campus in the state, no matter the program.	May	
Beta Club Scholarship: Over 250 scholarships are awarded each year, ranging in value from \$1,000 to \$15,000. Must be a member of Beta Club.	November	
Central Texas Farm Credit: Central Texas Farm Credit Bank gives away \$10,000 every year in scholarships to graduating high school seniors who are pursuing a career in an agricultural related field.	March	
Mary Michaels Memorial Scholarship: This endowed scholarship was given by Mr. WC Wilson, in honor of his mother-in-law, Mrs. Mary Michaels, a long-time Brown County teacher. Reciepent must be a Brown County student that is committed to entering the teaching profession. This is a \$1,000 scholarship.	April
