## 6. DIRECTOR OF SCHOOL'S REPORT

Mr. Blevins addressed the decision to close schools today and tomorrow due to illness. Mr. Blevins said our attendance yesterday was at 82% across the district thus, the decision to close for the rest of the week. He said a request for permission to close due to illness must be sent directly to the Commissioner of Education for approval and was sent immediately after our attendance numbers were available Mr. Blevins said all extra-curricular activities were also cancelled. Mr. Blevins did say the Daddy/Daughter dance sponsored by the Athens Parks and Recreation Department would still be held at McMinn this weekend along with the ACT at both high schools on Saturday morning.

Mr. Blevins welcomed new school board member, Mr. Rob Shamblin. He reminded the board of the other vacant position to be appointed by the county commission at the February 27<sup>th</sup> meeting with the deadline to submit an application on Monday, February 20<sup>th</sup>. Mr. Blevins said once we have our new board member, we will schedule a board ethics class which is done annually by our board attorney regarding the ethics and responsibilities of a school board member.

Mr. Blevins said our next regular session meeting was scheduled for March 9 which could conflict with the girls' state basketball tournament in Murfreesboro. Mr. Blevins said in thinking ahead, if we were to have any of our teams to qualify, we would consider moving the board meeting to Tuesday, March 14, 2017, if the board was in agreement.

Mr. Blevins stated the week of Spring Break would be March 19-24, 2017. He further stated that at the end of the meeting tonight, he would distribute the agenda for the school board workshop next week. Mr. Blevins said we do have several board policies that need to be reviewed and may need to have a policy meeting in March.

Chairman Howard informed the board that upon the new board member appointment, he and Ms. Brown would be conducting a new board member orientation for our three newly elected board members sometime in early March.

Sharon Brown stated she reviewed the tenure portfolios and said she was very pleased and excited to see what the teachers included in them. Ms. Brown expressed her appreciation to all the principals, teachers, and staff, for everything they received during School Board Appreciation Week.

Mike Lowry said he appreciated all of the invitations but his job conflicted with attending. Mr. Lowry congratulated Coach Johnny Morgan, girls' basketball coach at Central High School, on his 900<sup>th</sup> win after the game with McMinn County High School the other night.

Chairman Howard said he appreciated all the invitations during School Board Appreciation Week but due to his surgery, he was unable to attend.

Chairman Howard asked the board to remember all the meeting dates that were discussed tonight including high school graduations and to put these on their calendars.
