He said he appreciates their efforts with cleaning and sanitizing all the classrooms so students could return.

8. CHAIRMAN'S COMMENTS

Chairman Brown said each board member received a letter tonight from our school board attorney, Ms. Sarah Kennedy.

Ms. Kennedy said this letter was a reminder of the training requirements of a school board member. She said in the letter, it refers each board member to TSBA's website which has the information of the state requirements and a list of the training and dates for the required board modules. Ms. Kennedy stated in order to keep our state funding, this was just a friendly reminder to the board.

Ms. Cagle asked if there was a time frame to securing the points. Ms. Kennedy said for experienced board members as Ms. Cagle, the 7 hours of training is required annually. Ms. Kennedy further stated that TSBA required at least one module to be completed by 6/30/18 of each year. Ms. Kennedy further stated that TSBA requires board members to attend the required basic core modules first.

Mr. Blevins said he received notification from TSBA of twelve more policies being recommended for review and that we will need to have another policy committee meeting in March. Mr. Blevins said he hoped by this meeting date to have a presentation of the revisions to the high school dress code policy.

Chairman Brown reminded the board of the next regular session meeting to be held on Thursday, March 8, 2018 at 5:30 p.m.

Chairman Brown stated this concludes our meeting for tonight and asked for a motion to adjourn. A motion to adjourn was made by Mike Lowry, seconded by Melinda King. A voice vote was taken. Motion carried by unanimous vote.
