

The School District of Newberry County is accepting proposals for the following work at three locations:

Description of work

The scope of work for this project consists of the installation of plenum Cat5e cabling for an IP camera system, installation of IP cameras, running of all necessary conduits (metal where necessary), installation of all necessary software/licenses for cameras and a video camera server at each site. Vendor will be provided with IP address scheme when awarded the bid.

Vendor must be an authorized reseller of the IP cameras proposed and be certified to install and maintain the proposed cameras. Vendor must provide a letter from the manufacturer (on the manufacturers letterhead) stating that they are currently in good standing and meet the requirements listed above. All IP cameras must come with a minimum of a 3 years manufacturer's warranty with advanced replacement.

All copper connectivity will be rated for Category 5e performance and be plenum rated cable. All cables will be tested and labeled to comply with BICSI standards. All cables will have a 25 year warranty and submitted to the cable manufacturer for the activation of the warranty. Patch cables will need to be provided. Vendor must provide a letter from the manufacturer (on the manufacturers letterhead) stating that the cable meets the requirements listed above.

Furnish and install 13 interior IP cameras with drop ceiling mount kits and 7 exterior IP cameras. Preferred models are Axis P3344-VE and P1344-E. Equivalent or better cameras will be considered. Contractor will need to run plenum Cat5e cables/drops for cameras (in conduit where necessary). Furnish, install, and configure 1 rack-mount Video Recording server with ExacqVision server software. VMS licensing software required. Minimum server requirements: dual core processor, 4 GB RAM, 2 TB of storage with an 80GB HD for OS Partition. Operating System shall be 32 bit Windows platform. The vendor will provide installation of all necessary software/licenses for cameras on server.



Boundary Street Elem:

Furnish and install 17 interior IP cameras with drop ceiling mount kits and 7 exterior IP cameras. Preferred models are Axis P3344-VE and P1344-E. Equivalent or better cameras will be considered. Contractor will need to run plenum Cat5e cables/drops for cameras (in conduit where necessary). Furnish, install, and configure 1 rack-mount Video Recording server with ExacqVision server software. VMS licensing software required. Minimum server requirements: dual core processor, 4 GB RAM, 2 TB of storage with an 80GB HD for OS Partition. Operating System shall be 32 bit Windows platform. The vendor will provide installation of all necessary software/licenses for cameras on server.

Gallman Elem:

Furnish and install 15 interior IP cameras with drop ceiling mount kits and 9 exterior IP cameras. Preferred models are Axis P3344-VE and P1344-E. Equivalent or better cameras will be considered. Contractor will need to run plenum Cat5e cables/drops for cameras (in conduit where necessary). Furnish, install, and configure 1 rack-mount Video Recording server with ExacqVision server software. VMS licensing software required. Minimum server requirements: dual core processor, 4 GB RAM, 2 TB of storage with an 80GB HD for OS Partition. Operating System shall be 32 bit Windows platform. The vendor will provide installation of all necessary software/licenses for cameras on server.

Vendors must include all sales tax and applicable charges in the bid.

** Contractor will provide plenum cable, conduit where necessary, patch panels, video server, power injectors where necessary, patch cables, and cameras.
