<u>DEADLINE FOR SUBMISSION OF OFFER</u>: Any offer received after the Procurement Officer or his/her designee has declared that the time set for opening has arrived, shall be rejected.

DEFINITIONS - Except as otherwise provided herein, the following definitions are applicable to all parts of the solicitation:

AMENDMENT means a document issued to supplement the original solicitation document.

BOARD means the School District of Newberry County Board of Trustees.

BUYER means the Procurement Officer.

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract.

CONTRACT See clause entitled Contract Documents & Order of Precedence.

CONTRACT MODIFICATION means a written order signed by the Procurement Officer, directing the contractor to make changes which the changes clause of the contract authorizes the Procurement Officer to order without the consent of the contractor.

CONTRACTOR means the Offeror receiving an award as a result of this solicitation.

COVER PAGE means the top page of the original solicitation on which the solicitation is identified by number. Offerors are cautioned that Amendments may modify information provided on the Cover Page.

OFFER means the bid or proposal submitted in response this solicitation. The terms Bid and Proposal are used interchangeably with the term Offer.

OFFEROR means the single legal entity submitting the offer. The term Bidder is used interchangeably with the term Offeror. See bidding provisions entitled Signing Your Offer and Bid/Proposal As Offer To Contract.

PROCUREMENT OFFICER means the person, or his successor, identified as such on the Cover Page.

YOU and YOUR means Offeror.

SOLICITATION means this document, including all its parts, attachments, and any Amendments.

SUBCONTRACTOR means any person having a contract to perform work or render service to Contractor as a part of the Contractor's agreement arising from this solicitation.

WORK means all labor, materials, equipment and services provided or to be provided by the Contractor to fulfill the Contractor's obligations under the Contract.

<u>DISTRICT CLOSINGS</u>: If an emergency or unanticipated event interrupts normal District processes so that offers cannot be received at the Procurement Office designated for receipt of bids by the exact time specified in the solicitation, the time specified for receipt of offers will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which the District processes resume. In lieu of an automatic extension, an Amendment may be issued to reschedule bid opening. If District offices are closed at the time a pre-bid or pre-proposal conference is scheduled, an Amendment will be issued to reschedule the conference.

<u>DRUG FREE WORK PLACE CERTIFICATION:</u> The State of South Carolina has amended Title 44, code of Laws of South Carolina, 1976, relating to health, by adding Chapter 107, so as to enact the Drug-Free Workplace Act. (b) Intent to Award - Any actual bidder, offeror, contractor, or subcontractor who is aggrieved in connection with the intended award

or award of a contract shall protest within ten (10) days of the date notification of award is posted in accordance with this code. A protest shall be in writing, submitted to the appropriate chief Procurement Officer, and shall set forth the grounds of the protest and the relief requested with enough particularity to give notice of the issues to be decided. QUESTIONS FROM OFFERORS: (a) Any prospective offeror desiring an explanation or interpretation of the solicitation, drawings, specifications, etc., must request it in writing, either by mail or electronic communication (e-mail). Questions must be received by the Procurement Officer no later than May 26, 2017 @ 12:00 pm. Label any communication regarding your questions with the name of the Procurement Officer, and the solicitation's title and number. Oral explanations or instructions will not be binding. <u>REJECTION/CANCELLATION</u>: The District may cancel this solicitation in whole or in part. The District may reject any or all proposals in whole or in part.

RESPONSIVENESS / IMPROPER OFFERS:

- (a) Bid as Specified. Offers for supplies or services other than those specified will not be considered unless authorized by the Solicitation.
- (b) Responsiveness. Any Offer which fails to conform to the material requirements of the Solicitation may be rejected as nonresponsive. Offers which impose conditions that modify material requirements of the Solicitation may be rejected. If a fixed price is required, an Offer will be rejected if the total possible cost to the District cannot be determined. Offerors will not be given an opportunity to correct any material nonconformity. Any deficiency resulting from a minor informality may be cured or waived at the sole discretion of the Procurement Officer. (Article 5, Section 1520.13)
- (c) Price Reasonableness: Any offer may be rejected if the Procurement Officer determines in writing that it is unreasonable as to price. (Article 5, Section 1520.6.5.5).
- (d) Unbalanced Bidding. The District may reject an Offer as nonresponsive if the prices bid are materially unbalanced between line items or sub-line items. A bid is materially unbalanced when it is based on prices significantly less than cost for some work and prices which are significantly overstated in relation to cost for other work, and if there is a reasonable doubt that the bid will result in the lowest overall cost to the District even though it may be the low evaluated bid, or if it is so unbalanced as to be tantamount to allowing an advance payment.

<u>RESTRICTIONS APPLICABLE TO OFFERORS</u>: Violation of these restrictions may result in disqualification of your offer, suspension or debarment, and may constitute a violation of the state Ethics Act. (a) After issuance of the solicitation, all communications must be solely with the Procurement Officer. You agree not to discuss this procurement activity in any way with any other District employees, agents or officials. This restriction may be lifted by express written permission from the Procurement Officer. This restriction expires once a contract has been formed. (b) Unless otherwise approved in writing by the Procurement Officer, you agree not to give anything to any other District employees, agents or officials prior to award.

<u>SAMPLES-TESTING</u>: Free samples may be required for testing by the District's Facilities staff and/or an independent laboratory. If requested, your failure to provide a sample will result in rejection of your offer. Upon invoice, you agree to pay any reasonable cost incurred for this testing. Unless your sample is accompanied by a request for its return, your sample will not be returned. Your sample may be destroyed during testing.

SIGNING YOUR OFFER: Every Offer must be signed by the individual with actual authority to bind the Offeror. (a) If the Offeror is an individual, the Offer must be signed by that individual. If the Offeror is an individual doing business as a firm, the Offer must be submitted in the firm name, signed by the individual, and state that the individual is doing business as a firm. <u>SUBMITTING YOUR OFFER OR MODIFICATION</u>: (a) Offers and offer modifications shall be submitted in sealed envelopes or packages (unless submitted by electronic means) – (1) Addressed to the office specified in the Solicitation; and (2) Showing the time and date specified for opening, the solicitation number, and the name and address of the offeror. (b) If you are responding to more than one solicitation, each offer must be submitted in a different envelope or package. II. SCOPE OF WORK

A. GENERAL:

NOTE: Bidders are urged and cautioned to visit this project site to apprise them of conditions material to the completion of this project.

A SC General Contractors License is required to respond to this Invitation to Bid. Bidders must possess a license of Classification and Limitation as required by SC General Statue to respond to this Invitation to Bid.

Price offered shall be include the following - material, freight, installation, all applicable state and local sales and use tax, engineering costs, dismantling and disposal costs for existing bleachers, protection of owner's facility, and costs associated with specified training of school personnel.

- Prepare all drawings and submittals per attached specifications
- Provide all engineering services as required by specifications. A licensed Professional Engineer will review, seal and sign all submittal drawings.
- Dismantle and legally dispose of all existing gymnasium seating while fully protecting the gym floor and other areas of the owner's building and site.

Project includes the following:

Wall-attached telescoping stands; power operated with first tier recoverable wheelchair locations. To maximize seating, permanent wheelchair cut-outs are not permitted on this project.

Work Includes demolition and legal disposal of the existing bleachers.

Note: this section is a performance specification and is subject to alternates as listed. Proposals will require, upon owner request, submittal of documentation demonstrating compliance with the performance requirements prior to award.

This project must be complete by August 1, 2017. Unless otherwise approved by the District.

B. EXECUTION:

1. Examination

Examine areas where telescoping stands are to be installed, with Installer present, for compliance with requirements for installation tolerances and other conditions affecting performance of work.

Proceed with installation only after unsatisfactory conditions have been corrected.

2. Installation

Install telescoping stands to comply with referenced safety standard and manufacturer's written instructions.

3. Adjusting and Cleaning

On completion of installation, lubricate, test, and adjust each telescoping stand unit so that it operates according to manufacturer's written operating instructions.

Clean installed telescoping stands on exposed and semi-exposed surfaces. Touch up shop-applied finishes or replace components as required to restore damaged or soiled areas.

4. Demonstration

Engage a factory-authorized service representative to train Owner's maintenance personnel to adjust, operate, and maintain telescoping stands. Arrange training with Owner, with a minimum of seven days advance notice.

Provide detailed Operation and maintenance manual in hardcopy and digital format. Manual must contain an exploded axon drawing with part numbers demonstrating assembly and allowing ordering of parts with manufacturer's part numbers.

1) Provide price to provide manually operated bleachers in lieu or power operated seating as specified in Base Bid.

III. SPECIFICATIONS

A. SUBMITTALS & PROPOSAL FORMAT

Note; Please submit all information in a binder with tabs coinciding with the Sections a – h below.

- a. Product Data: Include construction details, material descriptions, dimensions of individual components and profiles, and finishes for telescoping stands.
- b. Shop Drawings: Include plans, elevations, sections, details, and attachments to other work. For telescoping stands, include structural analysis data signed and sealed by a professional engineer, licensed in a US State of Manufacture, responsible for their preparation. Include wiring diagrams for electrically operated units.
- c. Project List: Five (5) seating projects of similar size, complexity and in-service for at least five (5) years. Include name and address of facilities; contact person; date of installation and name of certified installer.
- d. Deviations: List of pre-approved deviations from these project specifications, if any. Deviations shall have prior written approval.
- e. Samples for Verification: For each type of exposed finish required, prepared on Samples of size indicated below.

Decking: 6-inch square samples of finished material. Metal Components: 6-inch square sample of each color and finish indicated. Seating: 6-inch square sample of each seating material, color, and finish indicated.

- f. Operation and Maintenance Data: For telescoping stands to include, operation, and maintenance manuals. Include warranty information, service requirements, operations manual and service contact information. Provide hard copies and electronic version of "as-built" drawings prepared in AutoCAD.
- g. Installer Qualifications: Provide proof of manufacturer's certified installer qualification.

B. QUALITY ASSURANCE

Installer Qualifications: Manufacturer's authorized representative who is trained and approved for installation of units required for this Project.

Manufacturer's Engineering Responsibility: Preparation of data for telescoping stands, including Shop Drawings, and comprehensive engineering analysis by a qualified professional engineer licensed in the US state of manufacture. Drawings must be submitted with a professional engineer seal from an engineer licensed in the state of Manufacture.

Safety Standard: Provide telescoping stands that comply with requirements in ICC 300 and the applicable requirements of the current applicable South Carolina State Building Code.

Welding: Qualify procedures and personnel according to AWS D1.1 "Structural Welding Code - Steel" and AWS D1.3 "Structural Welding Code - Sheet Steel."

Electrical Components, Devices, and Accessories: Entire system shall be UL Listed (motors, circuit protection, motor controls, user interface, enclosures, conductors and connectors all evaluated and approved for correct sizing and compatibility under maximum rated load on the motors) under UL Product Category FHJU, titled Electrical Drive and Controls for Folding and Telescopic Seating.

Accessibility Requirements: Provide telescoping stands that comply with requirements in the U.S. Architectural & Transportation Barriers Compliance Board's "Americans with Disabilities Act (ADA), and the Accessibility Guidelines for Buildings and Facilities (ADAAG)".

Service Requirement: The bleacher contractor must be able to show proof of full time service capability by factory certified technicians. Technicians shall be full time employees of the Bleacher Contractor. Subcontractors to the bleacher contractor do not qualify under this service requirement.

The bleacher contractor shall maintain a supply of reasonable service oriented parts in order to service bleachers on an on-going basis. Warranty: Manufacturer's standard form in which manufacturer agrees to repair or replace components that fail in materials or workmanship within specified warranty period.

Warranty period: Five-years from the date of substantial completion.

C. PROJECT CONDITIONS

Field Measurements: Verify actual locations of walls, columns, and other construction that will interface with telescoping stands by field measurements before fabrication and indicate measurements on Shop Drawings.

D. PERFORMANCE REQUIREMENTS

Gymnasium seating assembly; Design to support and resist, in addition to own weight, the following forces:

Seats and decking to resist live load of 120 lbs. per linear foot.

Uniformly distributed live load of not less than 100 lbs. per sq. ft. of gross horizontal projection.

Parallel sway load of 24 lbs. per linear foot or row.

Perpendicular sway load of 10 lbs per linear foot or row.

Hand Railings, Posts and Supports:

Uniform load of 50 lbf/ ft. applied in any direction at the top and to transfer this load through the supports to the structure.

Single concentrated load of 200 lbf applied in any direction at any point along the top and be capable of transferring this load to the structure.

Uniform and concentrated loads need not be assumed to act concurrently.

Guard Rails, Posts and Supports:

Uniform load of 50 lbf/ ft. applied in any direction at the top and to transfer this load through the supports to the structure.

Concentrated load of 50 lbf applied horizontally on an area of 1 sq. ft..

Infill load and other loads need not be assumed to act concurrently.

Posts and Supports: Engineered to withstand the following forces:

Concentrated load of 200 lbs. applied at any point and in any direction along top rail.

Uniform load of 50 lbs. per foot applied horizontally at top rail and a simultaneous uniform load of 100 lbs per foot applied vertically downward.

Member Sizes and Connections: Design criteria of the following shall be the basis for calculation of member sizes and connections:

AISC: Manual for Steel Construction.

AISI: Specification for Design of Cold Formed Steel and Structural Members.

AA: Specification for Aluminum Structures

E. PRODUCTS

a. Manufacturers

1. The product delivered and installed must comply with the Product Performance and Design Criteria of these Specifications. Proposals will require, upon owner request, submittal of documentation demonstrating compliance with the performance requirements prior to award. No pre-approval of manufacturers will be considered.

b. Materials

Wood:

Plywood: APA grade trademarked, DOC PS 1.

Steel:

Structural Steel Shapes, Plates, and Bars: ASTM A 36.

Galvanized Steel Sheet: ASTM A 653, G90 coating designation.

Uncoated Steel Sheet: ASTM A 1008, Designation CS (cold-rolled commercial steel), or ASTM A 1011, Designation CS (hot-rolled commercial steel).

Tubing: ASTM A 500, cold formed; ASTM A 501, hot formed; or ASTM A 513, mechanical.

Polyethylene Plastic: High-density polyethylene; molded, color-pigmented, textured, impact-resistant, structural formulation.

c. Telescoping Stands

Note: Bidders are cautioned that Bleachers will operate on an athletic wood floor. Provide structural analysis that maximum bleacher force on the floor shall be a static point load of less than 220 psi.

Description: Operable systems of multiple-tiered seating on interconnected folding platforms that close, without being dismantled, into a nested stack for storing or moving. Stand units permit opening and closing of adjacent rows, allow individual and collective rows to be locked open for use and close with vertical faces of upper skirts on the same vertical plane.

Wall-Attached Telescoping Stands: Rear of understructure permanently attaches to wall construction. Upper connection shall utilize a continuous 2" x 6" wall brace.

- 1. Operation: Automatic, friction-type integral power unit, with drive wheels located to allow for manual operation of first row seating.
- 2. Motor: Minimum ½ horsepower, 208V, 3Phase, 1.25 service factor.
- 3. Controls: Provide pendant style control switch capable of the following: Start; Stop; Forward and Reverse. Provide a second, spare switch for owner stock.
- 4. Safety Accessories: Provide the following safety features:
- 5. Coin round or roll all edges of exposed metal on top and underneath bleacher to eliminate sharp edges.
- 6. Provide polymer end cap on nose metal at bank ends and on the back of deck supports on the 1st 7 rows to prevent spectator injury. On 1st row, provide front and side skirt boards anywhere there is an exposed end to prevent players/balls from sliding underneath the first row.
- 7. Provide metal covers over motor chains and wheels to protect chains from debris and provide a safety switch that if cover is removed the power system will not work. Powered frames without a metal protective housing, covering drive chain and drive wheels are not permitted under this section.
 - 8. Provide metal end deck cover on each row to cover exposed edge of plywood at the ends of the bleachers.
- 9. Row Spacing: Adjustable between 22 inches and 26 inches. (First Tier set at 26" with balance of row spacing to be noted on approved submittal drawings.) Row Rise: 9-5/8 inches.
- 10. Bench Seats and Skirts: Material: Textured -molded polyethylene plastic with contour seat. Avoid the use of exposed metal parts and support brackets. Bench Height: Not less than 16 inches or more than 18 inches. Bench Depth: 10 inches with 1/2 inch minimum interlock at riser. Color(s): As selected by Architect from manufacturer's full range of standard colors.
- 11. Wheelchair-Accessible Seating: Provide manually operated retractable/recoverable first tier units (no larger than 4 seats in length) designed to be utilized without the use of front rails. Permanent cut-outs resulting in loss of seating are not permitted.

Decking shall be fabricated from 5/8" AC grade plywood, interior type with exterior glue. 5-ply, all plies Southern Pine with plugged cross-bands, produced in accordance with national Bureau of Standards' PS-1-97. Finish: Transparent finish. Painted and/or laminated surfaces are not acceptable.

- 12. Joints of plywood decking shall be tongue and groove or continuous metal splice. Metal splices must be recessed to prevent tripping hazard.
 - 13. Risers: Steel sheet with manufacturer's standard rust-inhibiting coating or hot-dip galvanized finish.
 - 14. Rails: Structural steel, finished with manufacturer's standard powder coat system.
 - 15. Color: As selected by the District from manufacturer's standard colors (10 color minimum).
- 16. Understructure: Structural steel designed to support loads described in this Section. Finish: Manufacturer's standard rust-inhibiting powder coat finish Color: Manufacturer's standard.
 - 17. Support Column Wheels: Non-marring, soft, rubber-face wheel assembly under each support column.

Include wheels of size, number, and design required to support stands and operate smoothly without damaging the flooring surface, but not less than 5 inches in diameter and 1-1/4 inch wide.

- 18. Fasteners: Vibration proof structural anchor bolts in manufacturer's standard size and material. Use of self-tapping fasteners is not acceptable.
 - 19. Accessories: As indicated below.

Slip-resistant, abrasive tread nosing at vertical aisles.

Intermediate aisle steps, fully enclosed, at each vertical aisle.

Removable front steps, fully enclosed, at each vertical aisle, that engage with front row to prevent accidental separation or movement and are equipped with a minimum of four skid-resistant feet.

Intermediate-aisle handrails located at centerline of each vertical aisle with seating on both sides.

End rails (guards) that are telescoping and self-storing.

Rear fillers including supports for closing openings between top row and rear wall of adjoining construction.

Gap fillers for closing openings between stand units or between stand units and adjoining construction.

Column cut-outs at intersection of bleachers and wall which prevent debris from falling behind stands.

d. Fabrication, Telescoping Stands

- 1. Fabricate understructure from structural steel members in size, spacing, and form required to support design loads specified in referenced safety standard.
- 2. Weld understructure to comply with applicable AWS standards.
- 3. Round corners and edges of components and exposed fasteners to reduce snagging and pinching hazards.
- 4. Form exposed sheet metal with flat, flush surfaces, level and true in line, and without cracking and grain separation.
- 5. Seating Supports: Fabricate supports to withstand, without damage to components, the forces imposed by use of stands without failure or other conditions that might impair the usefulness of seating units.
- 6. Cantilever bench seat supports to produce toe space uninterrupted by vertical bracing.

IV. QUALIFICATIONS

- An Offeror must, upon request of the District, furnish satisfactory evidence of its ability to meet all contractual requirements. Unreasonable failure to supply information promptly in connection with a responsibility inquiry may be grounds for determining that you are ineligible to receive an award.
- Offeror must have a minimum of five (5) years experience in providing bleacher and basketball inspection and maintenance services.
- The Contractor shall be licensed by the State of South Carolina to provide all services specified in this contract. All work shall be done under the superintendence of a State of South Carolina certified, responsible individual, in accordance with Federal, State and local laws and requirements. License number <u>must</u> be provided on Bid Response Form.
- Any certification received by the Offeror and/or Offeror's company shall be provided on Bid Response Form.
- Offerors must exhibit ability through references.

V. AWARD / CONTRACT TERM

Term of Contract/Option to Renew: Any contract resulting from this RFP shall have an initial contract period of one (1) year beginning June 1, 2017 through May 31, 2018. The District, at its discretion, may extend the contract for four (4) additional periods of one (1) year each, with an option of an additional two (2) periods of one (1) year each with Superintendent's approval. Contracts exceeding seven (7) years must be approved by the school board. Renewal on the part of the District will be based upon satisfactory contractor performance. Should either party wish not to renew the contract at the end of a contract period, notification shall be submitted in writing to the other party no less then ninety (90) calendar days prior to the contract renewal date.

The District's rights to terminate the contract during the contract period will be governed by Item 16 of the Terms and Conditions. All purchases are subject to the School District of Newberry County's Procurement Code and can be viewed at the Procurement Office upon request. The District reserves the right to accept or reject any or all bids and to waive any guidelines set forth if deemed to be beneficial to the District.

VI. TERMS AND CONDITIONS

- 1. <u>ASSIGNMENT</u>: No contract or its provisions may be assigned, sublet, or transferred without the written consent of the Procurement Officer.
- 2. <u>BANKRUPTCY</u>: (a) Notice. In the event the Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, the Contractor agrees to furnish written notification of the bankruptcy to School District of Newberry County. This notification shall be furnished within five (5) days of the initiation of the proceedings relating to the bankruptcy filing. This notification shall include the date on which the bankruptcy petition was filed, the identity of the court in which the bankruptcy petition was filed, and a listing of all District contracts against which final payment has not been made. This obligation remains in effect until final payment under this Contract. (b) Termination. This contract is voidable and subject to immediate termination by the District upon the contractor's insolvency, including the filing of proceedings in bankruptcy.
- 3. <u>CHOICE-OF-LAW</u>: The Agreement, any dispute, claim, or controversy relating to the Agreement, and all the rights and obligations of the parties shall, in all respects, be interpreted, construed, enforced and governed by and under the laws of the State of South Carolina, except its choice of law rules. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation.
- 4. CONTRACT DOCUMENTS & ORDER OF PRECEDENCE: (a) Any contract resulting from this solicitation shall consist of the following documents: (1) a Record of Negotiations, if any, executed by you and the Procurement Officer, (2) documentation regarding the clarification of an offer [Article 5, Section1530. 8], if applicable, (3) the solicitation, as amended, (4) modifications, if any, to your offer, if accepted by the Procurement Officer, (5) your offer, (6) any statement reflecting the District's final acceptance (a/k/a "award"), and (7) purchase orders. These documents shall be read to be consistent and complimentary. Any conflict among these documents shall be resolved by giving priority to these documents in the order listed above. (b) The terms and conditions of documents (1) through (6) above shall apply notwithstanding any additional or different terms and conditions in either (i) a purchase order or other instrument submitted by the District or (ii) any invoice or other document submitted by Contractor. Except as otherwise allowed herein, the terms and conditions of all such documents shall be void and of no effect. (c) Any document signed or otherwise agreed to by persons other than the Procurement Officer shall be void and of no effect.
- 5. <u>DISCUSSIONS WITH BIDDERS</u>: After opening, the Procurement Officer may, in his sole discretion, initiate discussions with you to discuss your bid. Discussions are possible only if your bid is apparently responsive and only for the purpose of clarification to assure your full understanding of the solicitation's requirements. Any discussions will be documented in writing and shall be included with the bid.
- 6. <u>DISPUTES:</u> (1) Choice-of-Forum. All disputes, claims, or controversies relating to an Agreement shall be resolved exclusively by the Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or a federal court in the State of South Carolina. Contractor agrees that any act by School District of Newberry County regarding an Agreement is not a waiver of either the District's sovereign immunity or immunity under the Eleventh Amendment of the United State's Constitution. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by this solicitation. (2) Service of Process. Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to an Agreement; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided, or by personal service, or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail.
- 7. <u>EQUAL OPPORTUNITY</u>: Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference.
- 8. <u>FALSE CLAIMS</u>: According to the S.C. Code of Laws Section 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime.
- 9. FORCE MAJURE: The Contractor shall not be liable for any excess costs if the failure to perform the contract arises out of causes beyond the control and without the fault or negligence of the contractor. Such causes may include, but are not restricted to acts of God or of the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, and unusually severe weather; but in every case the failure to perform must be beyond the control and without the fault or negligence of the contractor. If the failure to perform is caused by the default of a subcontractor, and if such default arises out of causes beyond the control of both the contractor and subcontractor, and without the

fault or negligence of either of them, the contractor shall not be liable for any excess costs for failure to perform, unless the supplies or services to be furnished by the subcontractor were obtainable from other sources in sufficient time to permit the contractor to meet the required delivery schedule.

- 10. NON-INDEMNIFICATION: Any term or condition is void to the extent it requires the District to indemnify anyone.
- 11. <u>NOTICE</u>: (A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used.
- 12. <u>PUBLICITY:</u> Contractor shall not publish any comments or quotes by School District of Newberry County employees, or include the District in either news releases or a published list of customers, without the prior written approval of the Procurement Officer.
- 13. <u>PURCHASE ORDERS</u>: Contractor shall not perform any work prior to the receipt of a purchase order from the District. The District shall order any supplies to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required.
- 14. <u>SETOFF:</u> The District shall have all of its legal, equitable, and statutory rights of set-off. These rights shall include, but not be limited to, the District's option to withhold for the purposes of set-off any moneys due to the Contractor under this contract up to any amounts due and owing to the District with regard to this contract including any contract for a term commencing prior to the term of this contract, plus any amounts due and owing to the District for any other reason including, without limitation, tax delinquencies, fee delinquencies or monetary penalties relative thereto.
- 15. <u>SURVIVAL OF OBLIGATION:</u> The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit.
- 16. <u>TERMINATION DUE TO UNAVAILABILITY OF FUNDS</u>: Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds thereof. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. Contractor will not be reimbursed any costs beyond the initial contract term.
- 17. <u>THIRD PARTY BENEFICIARY:</u> This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise.
- 18. <u>WAIVER:</u> The District does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the District's rights under this Contract. Any waiver must be in writing.

VII. SPECIAL INSTRUCTIONS

1. CHANGES:

- (1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:
 - (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [District] in accordance therewith;
 - (b) method of shipment or packing;
 - (c) place of delivery;
 - (d) description of services to be performed;
 - (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
 - (f) place of performance of the services.

Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

- (2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the District promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.
- (3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the District is prejudiced by the delay in notification.
- (4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.
- 2. <u>COMPLIANCE WITH LAWS</u>: During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs.
- 3. <u>CONTRACTOR'S LIABILITY INSURANCE REQUIREMENTS</u>: The successful contractor must furnish within ten (10) days after written acceptance of bid a copy of his Worker's Compensation and/or General Liability insurance certificate to the District. Worker's Compensation coverage shall meet the requirements of South Carolina law. It is agreed that the coverage, as stated, shall not be cancelled or altered until ten (10) days after written notice of any change has been sent by registered mail to the Procurement Department. School District of Newberry County shall be listed as Certificate Holder.

The certificate shall identify the types of insurance, state the limits of liability for each type of coverage, include a provision for 30 days notice prior to cancellation, name every applicable using governmental unit (as identified on the cover Page) as a Certificate Holder, provide that the general aggregate limit applies per project, and provide that coverage is written on an occurrence basis. (b) Prior to commencement of the work, contractor shall provide to the District a written endorsement to the contractor's general liability insurance policy that (i) names School District of Newberry County (as identified on the Cover Page) as an additional insured, (ii) provides that no material alteration, cancellation, non-renewal, or expiration of the coverage contained in such policy shall have effect unless the named governmental unit(s) has been given at least thirty (30) days prior written notice, and (iii) provides that the Contractor's liability insurance policy shall be primary, with any liability insurance of the District as secondary and noncontributory. 5. <u>CONTRACTOR PERSONNEL</u>: The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them.

- 6. <u>CONTRACTOR'S OBLIGATION</u>: The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. In no event shall any party be liable to another for any indirect, incidental, punitive, consequential, or special damages, including, without limitation, lost revenues and profits, even if it has been advised of the possibility of such damages.
- 8. <u>DEFAULT</u>: The District may terminate this contract, or any part hereof, for cause in the event of any default by the contractor, or if the contractor fails to comply with any contract terms and conditions, or fails to provide the District, upon request, with adequate assurances of future performance. In the event of termination for cause, the District shall not be liable to the contractor for any amount for supplies or services not accepted, and the contractor shall be liable to the District for any and all rights and remedies provided by law. If it is determined that the District improperly terminated this contract for default, such termination shall be deemed a termination for convenience.
- 9. <u>DESCRIPTIVE LITERATURE</u>: Your offer must include manufacturer's latest literature showing complete product specifications.
- 10. <u>DISPOSAL OF PACKAGING</u>: Contractor shall dispose of all wrappings, crating, and other disposable materials pertaining to this contract at the end of each working day and upon completion of installation.
- 11. <u>ILLEGAL IMMIGRATION</u>: By signing your offer, you certify that you will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agree to provide to the District, upon request, any documentation required to establish either: (a) that Title 8, Chapter 14 is inapplicable to you and your subcontractors or sub-subcontractors; or (b) that you and your subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." - 12. <u>INDEMNIFICATION-THIRD PARTY CLAIMS:</u> Notwithstanding any limitation in this agreement, Contractor shall defend and indemnify School District of Newberry County, its departments, board, and all their respective officers, agents and employees against all suits or claims of any nature (and all damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities attributable thereto) by any third party which arise out of, or result in any way from, any defect in the goods or services acquired hereunder or from any act or omission of Contractor, its subcontractors, their employees, workmen, servants or agents. Contractor shall be given written notice of any suit or claim. The District shall allow Contractor to defend such claim so long as such defense is diligently and capably prosecuted through legal counsel. The District shall allow Contractor to settle such suit or claim so long as (i) all settlement payments are made by (and any deferred settlement payments are the sole liability of) Contractor, and (ii) the settlement imposes no non-monetary obligation upon the District. The District shall not admit liability or agree to a settlement or other disposition of the suit or claim, in whole or in part, without the prior written consent of Contractor. The District shall reasonably cooperate with Contractor's defense of such suit or claim. The obligations of this paragraph shall survive termination of the parties' agreement.
- 13. <u>LICENSES AND PERMITS</u>: During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract.
- 14. <u>MATERIAL AND WORKMANSHIP</u>: Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended.
- 15. <u>OFFERING BY LOT</u>: Offers may be submitted for one or more complete lots. Failure to offer on all items within a lot will be reason for rejection.

- 16. OSHA CFR 1910.1200 (SCRR article 1, 71-1910.1200). By submission of this bid, the vendor agrees to take all necessary steps to ensure compliance with the requirements.
- 17. <u>OWNERSHIP OF DATA and MATERIALS</u>: All data, material and documentation prepared for the District pursuant to this contract shall belong exclusively to the District.
- 18. PRICE ADJUSTMENTS LIMITED BY CPI "Other Goods & Services": Upon request and adequate justification, the Procurement Officer may grant a price increase up to, but not to exceed, the unadjusted percent change for the most recent 12 months for which data is available, that is not subject to revision, in the Consumer Price Index (CPI) for all urban consumers (CPI-U), "Other Goods & Services" for products, as determined by the Procurement Officer. The Bureau of Labor and Statistics publishes this information on the web at www.bls.gov.
- 19. <u>SHIPPING/RISK OF LOSS</u>: F.O.B. Destination. Destination is the shipping location of the Districts' designated receiving site, as specified herein.
- 20. TERMINATION FOR CONVENIENCE: (A) Termination-The Procurement Officer may terminate this contract in whole or in part, for the convenience of the District. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective. (B) Contractor's Obligations-The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph. (b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the District, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated; (c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph: (i) contract prices for supplies or services accepted under the contract; (ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services; (iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph; (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated. (d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles. (5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the District's right to require the termination of a subcontract, or (ii) increase the obligation of the state beyond what it would have been if the subcontract had contained an appropriate clause.


